Herewith is the report of the Board of Trustees of the Grand York Rite of Utah Trust for the period since the last Grand York Rite Sessions 2018

Last year 2018 was not the best year we ended at \$291,314 having started at \$336,602. The loss was approximately 12.86% including \$2000.00 worth of disbursements. This was due to a failing market which many of us I'm sure felt in our own personal investments, 401k's etc. not to mention the Board working with our investment advisor in untangling the previous Wells Fargo advisor's investments.

However, thanks to the expertise of Alex Wheeler of RW Baird and the invest strategy adopted by this Board we have nearly recovered all of those losses. We started 2019 at \$291,314 and we are currently at \$333,926 or an increase of 14.64%

We have granted only disbursements for administrative tallies against the trust such as Secretaries stipend, supplies and the Accounting firm.

As a reminder once again, we started our account with RW Baird in October of 2016 with \$283,848 and \$1210.88 in the checking account for a total of \$285,058.88. We are up and more secure.

Alex Wheeler of RW Baird has worked diligently as previously mentioned in this report to remove us as surgically as possible from a one type of investment as Wells Fargo Advisors had us in to the spread risk investment we now follow.

Alex Wheeler whom many of you know already is a trusted financial advisor of the Grand Lodge of Utah, the AASR of Utah and many Blue Lodges. We attribute the professional management of our funds in general, the personal relationship we have established with our advisor and the investment strategy this board adopted the reason our monies are safe today. We continue to assert that no matter how long or who serves as a trustee we can and will have a consistent and proper vehicle in place ensuring the safe guard of our Trust funds for future generations of York Rite Masons.

We continue to work with Companion Benjamin Young of Stayner, Bates & Jensen, P.C. to handle our tax returns, etc. All tax returns, etc. have been filed to the IRS and are up to date.

We anticipate costs for the 2019-2020 year will be similar with previous requests and we again urge the incoming presiding officers to determine their funding wants and needs following these Sessions and that they meet with the elected Board Members as soon as possible to discuss and finalize these requests.

As an aside we are always willing to help aide and assist The Grand York Rite and would please ask the Grand Bodies that they prepare their budgets accordingly for items requested not in the spirit of the Trust's mission.

We wish to thank the York Rite Bodies for the opportunity to serve, Chuck Warren our Secretary and we will continue to administer our Trust to the best of our abilities.

#### **OFFICER REPORTS**

#### REPORT OF THE MOST ILLUSTRIOUS GRAND MASTER

Good morning and welcome to the 90<sup>th</sup> Annual Convocation of the Most Illustrious Grand Council of Cryptic Masons of Utah. Thank you all for attending this important annual event. Over this past year, it has been an honor serving as Illustrious Grand Master for this esteemed body. I want to thank the Brethren and Officers of this Jurisdiction for the support they have given me during my tenure. I made several decisions and had no disputes to settle between companions.

#### **Bylaw Changes:**

During my 2018-2019 term there was two request for a By-law Change: Zion #7 Cryptic Masons of St. George passed a change of their by-laws. Before, three York Rite Bodies met on the first Saturday of the month with the Council meeting at 10:00 am. This was changed to have the three York Rite bodies rotate their meetings each month and having the meeting start at 9:00 am. This change was presented to me on February 9, 2019. After reviewing the change, I approved the by-law change.

Solomon #4 Cryptic Masons of Price passed a change of their by-laws increasing the annual dues. This change was presented to me on March 14, 2019. After reviewing the change, I approved the by-law change.

#### **Dispensations:**

During the course of 2017-2018 I issued the following dispensations:

June 1, 2018: St. George York Rite Bodies requested to move their June meeting from June 2 to June 9 to accommodate those members who could not participate. The dispensation was granted.

October 5, 2018: St. George York Rite Bodies requested to move their October meeting from October 6 to October 13 to accommodate those members who participated in the Four Corners Festival. The dispensation was granted.

November 7, 2018: St. George York Rite Bodies requested to move their November meeting from November 3 to November 10 to accommodate those members who participated in the South West Regional York Rite Conference. The dispensation was granted.

December 31, 2018: Price York Rite Bodies requested to move their January meeting from January 2 to January 9 to accommodate those members who were traveling and observing the holidays. The dispensation was granted.

### **Special Convocations:**

The Grand Council was not opened in the interim between the 89<sup>th</sup> convocation in May, 2018 and the 90<sup>th</sup> convocation in May, 2019.

#### **Visitations:**

I had an official visitation with every Council within the State of Utah this year. They were as follows: Midvale October 24<sup>th</sup>, Ogden February 4<sup>th</sup>, Provo February 21<sup>st</sup>, Price March 6<sup>th</sup>, St. George April 6<sup>th</sup>, and Salt Lake City April 23<sup>rd</sup>. I appreciated the hospitality shown me on each visit.

Beyond the regular visitations, I visited Midvale on December 1 for the installation of the officers for both the Midvale York Rite Bodies and the Social Order of the Beauceant. I also participated in the York Rite Mini festivals put on by the various York Rite Bodies on February  $16^{\rm th}$  in Bountiful (Chapter), March  $30^{\rm th}$  in Ogden (Council/Red Cross/Malta) and May  $4^{\rm th}$  in Provo (Order of the Temple).

Unfortunately, I was unable to attend the Ogden Council #3 fund raising dinner for the Cryptic Mason Medical Research Foundation as I was traveling. However, Grand Council Officers did attend in my absence. I am very grateful for the invitation and the funds raised by the Ogden York Rite Bodies.

#### Awards:

The Cryptic Mason of the Year and Adult Youth Leadership awards were authorized and will be presented at this convocation.

#### **Recommendations:**

The following recommendations are as follows:

As in previous years, many of the Councils in this state have not had the requisite number of members to open their Council. On more than one occasion, the Council was only able to open because the Grand Council officers were visiting. This is a disturbing fact and underlies the fundamental issue facing the York Rite in this state: lack of membership and lack of participation. We have spent much time discussing ways to increase the number of York Rite Masons and I will not repeat them here. But I do want to focus on the lack of participation which feeds into the problem we have with retention Retaining members is of vital importance to the health of these bodies. As we all know, we lose more members to NPD and demits than to passing away. This is a failure on our part because these brothers had made a decision to join our bodies and then found no reason to stay. Whatever they were looking for, we didn't provide. Many of them found that the York Rite was just another monthly business meeting where we went over budgets and read regrets. We need to focus on what the Brethren want when they come through our door. We need to focus on education and comradery. We need to give them a reason to leave their homes and travel to the nearest York Rite meeting. We need to communicate with our new Brothers and understand what they want. We also need to increase participation of our new Brothers, either in educationals, ritual, our charities and in dinners or other social events. If York Rite is to survive, we must transform ourselves from being just another meeting where minutes are kept and hours are lost.

I also recommend here that we reinstitute the statewide Festival. While it is the ideal that individual bodies do their own work, it is increasingly

apparent that this is not always feasible. Many bodies lack in members and participation and it has become difficult for individual bodies to perform all the degrees. I propose that while we still encourage individual bodies to perform the degrees, the Grand York Bodies conduct a Chapter/Council festival one weekend and the Commandery degrees on another weekend (not necessarily consecutive). This would help Bodies that are struggling to get new members through.

Finally, I want to express my gratitude to the York Rite Masons of Utah for bestowing me with the honor and responsibility to serve as your Illustrious Grand Master for the preceding year. I also thank the Companions who faithfully served as officers during this last year. I finally want to thank all the members of Councils throughout this state for their hard work and dedication to the York Rite of this state. I hope to continue to serve the Grand Council and the York Rite of the State of Utah and work to make York Rite Masonry strong.

#### HOLY LAND PILGRIMAGE REPORT

This presentation was made to all six Utah York Rite Bodies this year:

As Knights Templar we have a duty to support and defend the Christian Religion. As part of that duty Knights Templar of Utah have for many years been sending full time, ordained ministers from various denominations to the Holy Land. The purpose is to strengthen Christian ministry by providing an intensive travel and study program. Experience tells us how much the opportunity to "walk where Jesus walked" can positively affect the preaching, teaching, and spirituality of Christian Ministers. It is our plan to immerse the Pilgrim ministers in the land, the sights, the sounds, the history and the cultures of the Holy Land, past and present.

The program for many years was directed by Past Eminent Grand Commander Ray White who passed away. Sir Knight White did an excellent job for many years. We started up the program again last year and we need to raise about \$4,000 to cover the cost to send a minister. Some Commanderies have made some contributions already but we are at most half way. When we get to our goal we can send a qualified minister from Utah. Each Commandery may nominate a minister from their area who will be evaluated by the Holy Land Pilgrimage Committee. As much as possible, depending on qualifications, we will try to have each Commandery have a turn in sending a minister from their area.

Fundraising suggestions: Dinners, go to churches wear your Commandery uniform (no sword or chapeau) to explain the program and ask for donations. I did a presentation at All Saints Episcopal Church and raised over \$500. I was fortunate because the Minister there had been sent to the Holy Land Knights Templar in Massachusetts when he was serving there. I am providing a contribution form for the three charities presented. I know money is sometimes tight and there are 10 places that every dollar

Whereas the Grand Encampment omitted the following section of the Grand Encampment laws Section 66 "A quorum of a commandery consists of nine (9) members entitled to vote therein, including an officer authorized to open the same. The Grand Commandery may, by law, provide a lesser number for quorum purposes provided that such a number shall not be less than five (5)."

I now therefore resolve that the Grand Commandery of Utah laws, Title III, Section 3-5, Quorum, be amended to read as follows: "A quorum of a Commandery consists of nine (9) members, including an officer authorized to open the same, however, of these nine (9) members, five (5) must be entitled to vote therein."

## ROYAL ARCH RESEARCH ASSISTANCE

This presentation was made to five Utah Royal Arch Chapters in 2019: Central Auditory Processing Disorder

Central Auditory Processing Disorder (or CAPD) is a hearing deficiency that usually affects younger people and does not allow them to distinguish sounds as would be heard by those with regular hearing. Background noises and other speakers disturb and confuse people with CAPD making it difficult to concentrate. This results in misunderstanding and/or frustrations leading to students being accused of being dysfunctional. Often students with satisfactory IQ's produce substandard work because they

cannot hear messages or a teacher's delivery clearly. Research is developing paths of opportunity to correct this problem and RARA contributions support these research efforts. Our activities go back over 30 years and much progress has been achieved through these efforts. More needs to be done and that is why RARA has expanded their efforts.

# **Autism Speaks**

Autism strikes 1 in 110 births and 1 in 70 boy births so it is a major problem in the world today. Autism Speaks has become very well known throughout the country as they strive to help the more and more children that are diagnosed with this problem. The challenge in this area goes much deeper than children and their parents who are provided with special training in dealing with this difficulty, but becomes increasingly difficult for parents as they become older and plans must be made for the days when those parents will no longer be able to provide the care and support needed. Our activity with this highly visible organization should benefit both immeasurably. Royal Arch Masons will be able to participate in the more than 90 "Walks" around the country, challenging greater contributions and making Royal Arch Masons visible doing good works in the community.
