GRAND TREASURER'S REPORT

No report submitted

REPORT OF THE GRAND SECRETARY/RECORDER

As the Grand Secretary/Recorder during this unprecedented time, we have had a most eventful year. Although most events and meetings have been cancelled, I did have the opportunity to attend the Southwest Regional Conference in November 2019 along with visiting multiple Local York Rite Bodies prior to shut down. I also attended the New Mexico Grand Sessions via Virtual.

Although this has been an unprecedented 14 months due to COVID 19, numerous housekeeping items have been updated, corrected, etc. This has been an exciting administrative 14 months, including the following:

- **QuickBooks** – Grand York Rite purchased the program to implement a structured fiscal accounting program. With the assistance of Jen Dunn, Grand York Rite of Utah now has a broken out operating reporting system. The challenge to the Finance Committee is to develop a budget for all (3) three Grand York Rite Bodies, to roll-up into a total operating budget for each fiscal year.
- **Fiscal Year** – One of the Code proposals is to make the fiscal year aligned with the calendar year of January 1st to December 31st. The most important reason amongst numerous others is the fact that Grand Encampment is January 1st – December 31st, for Annual Returns along with annual assessments. With the local Bodies reporting different than that which Grand Encampment reports on MMS, there was been multiple challenges along with inaccurate payments being made. Also, by using the calendar year starting on January 1st, this also

aligns with our Grand Lodge of Utah and other appendant Bodies.

- **MMS** – This is the online Grand Encampment Knights Templar Membership Program, which also includes the membership information for Chapter membership and Council membership. At the 2019 Southwest Regional Conference all Grand Commanderies were tasked with getting all State membership information input into the system to provide accurate membership for all (3) three Bodies. This online program, if used and kept up to date is a fantastic tool to generate the membership reports very easily along with having accurate data on each Companion/Sir Knight. I am very excited to report that all the local Body Secretary/Recorders have worked diligently to keep/input the records up to date for their Commandery, Chapters and Councils. This a major undertaking, especially for those Bodies starting from scratch for Chapter and Council and all should be commended.
- **Grand York Rite Website:** Treavor Wilkinson was appointed as the Web Administrator and has spent a great deal of time developing the new site, adding items, etc. A major goal is to have the Grand York Rite website interactive and a place to go for needed tools, key links, along with Grand Communications. Work continues as updates are added and looking forward to a place that all Companions/Sir Knights can utilize.
- **Annual Returns** – We now have fully automated/drop down boxes for all (3) Bodies to input their data for their Annual Returns. This has streamlined the process, moving forward this will provide both the Secretary/Recorders and Treasurers a quick and consistent reporting process at close of the year on December 31st.
- **Tax Filing** - I can report that as of July 1st, 2020 all (3) three Bodies are up to date on 990's.

- **Incorporation** – The Grand York Rite of Utah was Incorporated as a nonprofit organization the first week of July along with applying for an EIN. This needed to happen to continue the process of moving the investment fund from Merrill Lynch.
- **2021 Time & Place** – Utah Grand York Rite 2021 Sessions venue has been secured at the Marriott University Park, Salt Lake City, Utah,
- **Grand Code** – A big thank you needs to go out to Marty and Jen for all their hard work on reviewing the current code, including adding Amendments and proposing Housekeeping Amendments. There was much time and research going back many years to bring the Code up to date for Amendments that needed to be added after being approved at Grand Annual Sessions.
- **Inventory Supplies:** We are in the process of counting and adding the value of rituals, award pins, medals etc. to the QuickBooks program. This will provide accurate quantities along with accurate invoicing to the Local Bodies and reordering needed supplies. This should be a line item included in the Annual Budget adopted by Finance.
- **Debit Card:** We now have a Debit Card for the Grand York Rite of Utah.
- **Investment Fund:** Although this falls under the reporting of the Finance Committee, one of the tasks I have been given is moving the monies from Merrill Lynch. The reason is that due to the size of the current account it does not fall under the minimums that Merrill Lynch requires to maintain the account. We have had many challenges with this account from not being able to find it registered under a nonprofit to the Tax ID numbers not matching. This was one of the main reasons that we needed to Incorporate the “Grand York Rite” along with a Fed #. Those two issues have made the account impossible to transfer/close out. At this point the account is

still under Merrill Lynch and still pending for Baird to assume the investment. The best suggestion right now is to close it out and have the money initially deposited into the Grand York Rite checking/savings. At that point, the Finance Committee can review the funds, develop a working operating budget (which currently is in the red) and then start with a “clean” investment fund with Baird. The Grand York Rite of Utah is not registered as a Tax-Exempt Organization with the State of Utah and does not have a Tax-Exempt Certificate. I recommend that this be investigated by the Grand York Rite at the possible earliest date/meeting.

- **Annual Return Assessments:** I would encourage that the Finance Committee, set aside a meeting to review current receipts versus payouts, expenses, etc. At the current levels dealing with the invoices, receipts, returns, etc. the Grand York Rite of Utah is not on solid ground from a yearly “operating income”. There are no “rainy day” funds, there is no seed monies for Sessions, etc. While we do have a Trust Fund and Investment Fund, without working capital to pay bills, down payments for “Sessions”, etc. those Funds frankly provide no benefit to the monthly running of the Grand York Rite of Utah. Does this mean that there should be a hard look at how low the income is in the checking account vs. money that is not touched, yes? Does this mean either funds come out of those accounts or an increase to all Local Bodies annual assessments? These are very hard questions, however, not being the alarmist, but as your Grand Secretary/Recorder, the financial income needs to be addressed to pay the bills.
- **ZOOM Pro Account:** With the need for a Virtual Sessions, we (“GYR”) have signed up for a year’s subscription. The account is being billed monthly, which provides for unlimited monthly meetings in addition to no limit to the amount of time (40 minutes) for the basic “free” version. This now also provides a communication avenue for all the GYR Committees to schedule and meet online to perform the

needed tasks, i.e. Finance, Membership, etc. After those priority groups and the Grand Heads schedule meetings as, appropriate, then the site can be offered to other Appendant Bodies to use.

- **E Ballot Account:** Also, with the need for a Virtual Sessions, we (“GYR”) have signed up for a one-year subscription. This is entitling Grand York Rite the ability to have as many voting ballots as needed along with Grand York Rite Committees for the upcoming year.
- **Grand Chapter Name Badges:** I let this challenge speak for itself as another financial challenge and should be clarified on what is paid by the Grand Officer and what is paid up by the Grand York Rite Body without sufficient funds to have them made. This would be another line item that should be budgeted by the Finance Committee.
- **State Awards:** This has been a challenge with a lot of questions from the Local Bodies on applications, deadlines, etc. There is a fee for each person honored that covers the cost of the Medal. It does not cover the cost of the mailing or printing a Certificate. Which brings up the matter of State Award Certificates. There is a homemade Certificate that we should give Chuck Warren kudos for, however, we do not have a standard template/Certificate for the numerous Awards, which leaves it wide open to interpretation. I would recommend that a special committee be appointed by the newly elected Grand Heads to developed Award Certificates for each of the State Honors and factor a cost and this be presented to the Finance Committee to factor into the early operating budget. I would also recommend that a yearly date be imposed to when all the names be presented to the Grand Heads for approval and named. As it stands right now, names can be presented throughout the year, which can cause confusion and follow through with getting the payment for the award and the medal received by the local Body for presentation. I would recommend the deadline for all

nominations be submitted with payment by December 31st, to be issued the month of January to the appropriate local Body and/or Grand Head for presentation. This provides time for the outgoing Local Heads and the incoming Local Heads to name their choices at the end of their year as well.

- **KTCH Grand Encampment Award:** This award is under strict time frames if it is to be presented at the Grand York Rite Sessions in May (under normal times). After numerous emails and reminders there were no names provided by the Local Commanderies for the 2019 year. Although this window was missed to be submitted to the KTCH recommending Committee I would suggest to all future Grand Commanders that you ultimately have the final word and it's your approval on who gets submitted to Grand Encampment and if no names were submitted to the Committee that this highest Honor not be lost for an entire year to a most worthy Utah Knights Templar. While this is not the norm to make this decision alone by the Grand Commander, should a worthy Knights Templar be penalized for not being submitted to the Committee cut off time, I would encourage the Grand Commanders to contemplate this decision during your tenure in the Chair.

I hope the recommendations and report has provided a good base line understanding of the past 14 months in review. I welcome all the assistance and feedback to make sure I have performed to the best of my ability and to maintain the functions of the Grand Secretary/Recorder.

I need to recognize a very special group of people who stepped up to the plate to work many, many hours on the backend to bring great talent and expertise to put this Virtual Sessions together namely, Treavor Wilkinson, Jenafer Dunn, Timothy Stenner, David Hutchison, Daniel Drew and Monte Anderson. Years down the road, when folks are reading past proceedings, I hope that they be remembered. I also, would like to thank the Members of Jurisprudence, Grand Heads and 2nd Chairs, without their support and input we would have had more challenges than can be named. I can't thank everyone on this report individually but thank you all.

This has been a year of learning and I would like to thank Companion/Sir Knight Chuck Warren for his support and guidance taking on this important responsibility over the past 14 months.

Herewith is the report of the Board of Trustees of the Grand York Rite of Utah Trust for the period since the last Grand York Rite Sessions 2019

Last year 2019 we finished at \$361,643. Due to the Covid-19 epidemic our investments in the second quarter took a substantial hit as low as \$292,448 at one time. I am pleased to say that we have recovered most of that and YTD stand at \$348,665. Just down \$12,978.

I again thank the expertise of Alex Wheeler of RW Baird and the invest strategy adopted by this Board. None of us knowing what is coming in the next few months still makes me feel better with Alex at the controls.

We have granted only disbursements for administrative tallies against the trust such as Secretaries stipend, supplies and the Accounting firm.

Alex Wheeler of RW Baird should be scheduling a virtual meeting with us soon to go over and possibly modify the investment strategy with all the aforementioned uncertainty in the world.

Joint Grand York Rite Sessions

We continue to work with Companion Benjamin Young to handle our tax returns, etc. All tax returns, etc. are currently being prepared yet not filed as of this date for 2019. Thanks, Covid.

We anticipate costs for the 2020-2021 year will be similar with previous requests and we again urge the incoming presiding officers to determine their funding wants and needs following these Sessions and that they meet with the elected Board Members as soon as possible to discuss and finalize these requests.

As an aside we are always willing to help aide and assist The Grand York Rite and would please ask the Grand Bodies that they prepare their budgets accordingly for items requested not in the spirit of the Trust's mission.

REPORTS OF OFFICERS

REPORT OF THE GRAND COMMANDER

It was an honor and privilege to serve the Grand Commandery of Utah as Right Eminent Grand Commander for the 2019-2020 term. This year has presented many unique challenges not just for Knights Templars but also for all of Freemasonry and the entire world. The COVID-19 pandemic prompted both the Grand Master of the Grand Encampment and the Grand Master of the Grand Lodge of Utah to issue edicts ending large gatherings and meetings. As your EGC, I honored these edicts not only out of Masonic obligation but also for the well-being of our membership. Many of our members are more seasoned and can be placed at great risk by meeting in large groups.

The pandemic has caused a serious disruption in the business of the Grand Commandery and for the Grand York Rite Sessions of Utah. In discussions with our Grand High Priest and Grand Illustrious Master, we agreed first to move the date of our meeting from early May to mid-July. But when it became obvious that any face-to-face meeting was not possible, we agreed to replace the live meeting with the Zoom format. I want to thank our Grand Recorder and the members of the special committee for all their hard work in making this possible. There will obviously be glitches and other issues associated with this inaugural Zoom meeting but we expect to learn from our mistakes and have a smoother meeting if the need arises.

My gratitude also goes out to the Grand Commandery Officers for this year. Your support has been most appreciated and I wish all the best in the upcoming year. I also want to thank our Southwest Department Commander Dean Rein for all of his support in this unusual year.

The Grand Commandery of Utah and its Sir Knights continue to actively support the Knights Templar Eye Foundation, one of the great charities in Masonry. Utah's support for the KTEF has been disproportionate to our Commandery's size and we should all take great pride in that accomplishment. I was honored on June 7, 2019 to

be present when a sizable check was donated to the Moran Eye Center for its continued research into diseases affected vision. I have full confidence that we continue to support such endeavors in the years to come. Our continued support of the Holy Land Pilgrimage is also a cause of pride for our Grand Commandery.

I was honored to participate in the Honor Guard for the Job's Daughters Pageant on September 14, 2019 and thank my fellow Sir Knights for their participation. I could not attend the Southwest Regional in Las Vegas due to conflicts but did attend the Northwest Regional in Boise on October 18-19 2019. I met many fellow Knights and learned a great deal of information about both our Fraternity and charity. The highlight of my year was participating in the installation of Sir Knight Clay Hamblen as Grand Master for the Grand Lodge of Utah on February 1st, 2020 in the Salt Lake Masonic Temple. I also participated in various York Rite degrees in February and March as we continue our efforts to reinstitute the York Rite Festival. We were unable to finish the Commandery orders as they were scheduled for April.

A disappointment for me this year was the cancellation of many visitations to our local Commanderies. My schedule was weighted towards the spring and with the exception of Midvale (November 20) and Ogden (March 2), I was not able to meet with my fellow Sir Knights. It was also disappointing that our Easter Observances were also cancelled this year.

Bylaw Changes:

During my 2019-2020 term there was one request for a By-law Change:

El Monte #2 Commandery of Ogden passed a change of their by-laws. The members voted to amend that portion of Article VII Sec 2 regarding annual dues to read as follows: The annual dues of the members shall be Forty (\$40.00) payable in advance on or before the first day of January of each year. This change was presented to me on

October 1, 2019. After reviewing the change, I approved the by-law change.

Dispensations:

During the course of 2019-2020 I issued the following dispensation: March 8, 2020: Provo York Rite Bodies requested to move their March meeting from the 19th to the 26th and the April meeting from the 16th to the 23rd. This was in response to conflicts with other Masonic events. The dispensation was granted.

Special Convocations:

The Grand Council was not opened in the interim between the 90th convocation in May, 2019 and the 91st convocation in August, 2020. I am encouraged by the enthusiasm of many of our Commanderies and Sir Knights. I am continuously impressed by the quality of our degree work. The Orders of Commandery (especially the Order of the Temple) are among the most impressive rituals in Masonry and our continued excellence in presenting them shines as an example to other Masonic Bodies. I am also encouraged by the local York Rite bodies that conducted Zoom meetings throughout the year. This may become the new normal and by moving forward in this area, we will be better prepared for any future disruptions.

There are still several areas of concern with the state of York Rite Masonry in Utah. Particularly, poor attendance has caused meetings to be cancelled or official business not be conducted. On one occasion, a meeting only occurred because the visiting Grand Commandery Officers brought the number present to the necessary prerequisite. We need to promote our meetings to our inactive Knights. We need to give them reasons to leave their homes for the evening to join with us such as fellowship, ritual and education. I was also disappointed that there were no nominations for the KTCH award and therefore have decided not to give one out this year. The other York Rite Grand bodies have had similar problems over the year with participation in these awards. These are important awards and need

to be bestowed on worthy Knights. It is therefore very important that the local bodies send in nominees for the committee to analyze.

In conclusion, thank-you for privilege of serving this past year. I offer my assistance to my successor and will work for the benefit and continued success for Grand Commandery of Utah and the York Rite in Utah.

LEGISLATION

PROPOSED AMENDMENT TO SECTION 2-25 AMENDMENTS

Whereas the **Section 2-25 AMENDMENTS** appears to have a “cut and paste” error in the last paragraph

And whereas this error does not appear in the Grand Council Cryptic Masons of UT Bylaws.

And whereas the three Grand Bodies should be in accord with bylaw sections pertaining to Joint Committees.

Be it resolved to amend the By-laws **2-25 AMENDMENTS** to read as follows

Section 2-25 AMENDMENTS

AMENDED MAY 1990

All proposed amendments to the Laws relating to Grand Commandery shall be submitted in writing to the Grand Recorder at least forty five days before the next annual communication. At least THIRTY FIVE days before such annual conclave of Grand Commandery the Grand Recorder shall transmit to the Recorders of the several constituent Commanderies of this jurisdiction, and to the members of the Jurisprudence Committee of Grand Commandery, copies of any such proposed amendments.

All proposed amendments shall first be referred to the Committee on Jurisprudence for its opinion and report. Any proposed amendment, ruled by the Committee on Jurisprudence to be "not" in proper form, shall not be placed upon the floor of the annual conclave of the Grand Commandery, for vote, until said amendment shall have been put in proper form. Responsibility for "Proper Form" shall be with the author of the amendment.

The Committee on Jurisprudence shall advise the author, or authors, of proposed amendments, prior to the annual conclave, if such amendments are "not in proper form". If the amendment is then approved in annual convocation by a majority of the votes, then such amendment shall become effective. Grand Commandery may suspend the forgoing provisions by two-thirds vote at the Annual Conclave or a Special Conclave called for such Purpose.

CHANGE LAST PARAGRAPH TO READ:

The Committee on Jurisprudence shall advise the author, or authors, of proposed amendments, prior to the annual conclave, if such amendments are "not in proper form". After "proper form" is satisfied, if the amendment is then approved in annual convocation by a majority of the votes, then such amendment shall become effective. Grand Commandery may suspend the forgoing provisions by two-thirds vote at the Annual Conclave or a Special Conclave called for such Purpose.

PROPOSED CHANGE TO THE “KNIGHT TEMPLAR UNIFORM REGULATIONS FOR CONSTITUENT COMMANDERIES OF UTAH” – SHOULDER STRAPS

Whereas the Knight Templar uniform regulations for the state of Utah are to make sure that we have conformity to the uniforms so prescribed.

And whereas the Knight Templar uniform is first and foremost a uniform

And whereas the uniform of a Sir Knight below the rank of Captain General looks more like a suit and less like a uniform

And whereas the shoulder straps on the dress uniform add to the overall look of the Knight Templar

And whereas the Grand Encampment of Knights Templar, USA has allowed for the wearing of shoulder straps on the uniforms of all Knights Templar

Be it resolved to change the “Knight Templar Uniform Regulations for Constituent Commanderies of Utah” Dress Uniform; Section A

To add sections

For Prelates during incumbency in office:

The entire full dress uniforms AA or AB for Prelate shall be the same as for Generalissimos except for the following may be worn;

Shoulder Straps

The same as for Commanders except that the triple triangle with small Passion Cross in the center may be used instead of the Passion Cross.

For Recorders during incumbency in office:

The entire full dress uniforms AA or AB for Recorder shall be the same as for Generalissimos except for the following may be worn;

Shoulder Straps

The same as for Commanders except the crossed quills in the center may be used instead of the Passion Cross.

For Treasurers during incumbency in office:

The entire full dress uniforms AA or AB for Treasurer shall be the same as for Generalissimos except for the following may be worn;

Shoulder Straps

The same as for Commanders except the crossed keys in the center may be used instead of the Passion Cross.

For Past Deputy Grand Commanders, Past Grand Generalissimos and Past Grand Captains General:

The same as for Grand Commandery officers; except with the initials of the office respectively, to be embroidered in Old English characters, of silver bullion, on the lower end of the strap.

And change the following section to read;

For Sir Knights and Officers Below the Rank of Captain General

The entire full dress uniforms AA or AB for Sir Knights and Officers below the rank of Captain General shall be the same as for Generalissimo, except ~~the Shoulder Straps are Omitted~~ for the following may be worn;

Shoulder Straps

Shall be black silk, (1 $\frac{3}{4}$) one and three fourths inches wide by (4) four inches long, bordered with one row of embroidery, of gilt or real silver bullion (3/8) three-eighths of an inch wide, the cross of red silk bordered with one row of embroidery, of gilt or real silver bullion (1/8") one-eighths wide.

Whereas, the Uniform regulations of the Grand Commandery of Utah dictate the allowed uniform for Sir Knights in Utah Commanderies,

and whereas the Uniform Regulation of the Grand Encampment dictates the allowed uniforms for all Grand Commanderies.

Let it be resolved to make clarification in the Uniform Regulations of the Grand Commandery of Utah with regards to the Military style Naval Dress Cap or Pershing Cap.

Whereas, the current Uniform regulation (2014) states,

MILITARY STYLE NAVAL DRESS CAP

In lieu of the chapeau, The Grand Commandery of Utah, has adopted a Military Style Naval Dress Cap of the following description:

For Past Grand Commanders

Military Style Naval Dress Cap with white top, black band, and black visor with one row of gold oak leaves and acorns, metal purple Templar Cross 2 ¼ inches square, fixed to the front of the black band and a gold chin strap attached with gold buttons.

For Grand Commander

Same as above except red Templar Cross.

For Grand Commandery officers

Same as Grand Commander except plain black visor.

For Commanders and Past Commanders

Same as above except with a 1 3/8 x 2-inch red metal Passion Cross trimmed in gold with rays.

For all other Sir Knights

Same as above except using a red metal Passion Cross trimmed in silver with a silver chin strap attached with silver buttons.

Let the Regulation be changed to state the Following;

Pershing style Cap

In lieu of the chapeau, The Grand Commandery of Utah, has adopted a Pershing style Cap of the following description:

For Past Grand Commanders

Pershing style Cap with black or white top, black band, and black visor with one row of gold oak leaves and acorns, metal purple Templar Cross 2 ¼ inches square, fixed to the front of the black band and a gold chin strap attached with gold buttons.

For Grand Commander

Same as above except red Templar Cross.

For Grand Commandery officers

Same as Grand Commander except plain black visor.

For Commanders and Past Commanders

Same as above except with a 1 3/8 x 2-inch red metal Passion Cross trimmed in gold with rays.

For all other Sir Knights

Same as above except using a red metal Passion Cross trimmed in silver with a silver chin strap attached with silver buttons.

This change corrects the description of this headwear in the Uniform Regulation of the Grand Commandery of Utah and brings it in closer conformity with the Uniform Regulations of the Grand Encampment.

At some point in the past the funds of the Knight Templar Education Committee of Utah was transferred to the Grand Encampment due to lack of interest in the program. At this time the Sir Knights were urged to take advantage of the Masonic Foundation of Utah which continues to offer scholarships to students in Utah that wish to pursue higher education at Universities.

The money that was transferred to the Grand Encampment is invested by them and at the end of the 2019 fiscal year Utah's portion stands at \$9,100.29.

If an interest in this program reemerges then the funds can be returned and used for the benefit of students for the purpose of educating students at the university level. However, a minimum balance must be maintained at all times. The amount available due to this restriction would, in my opinion, be minimal and ineffective. Fundraising for donations would be necessary for many years for it to be viable.

The following presentations were made to all Utah Chapters either in person before the Covid-19 pandemic or via email after the pandemic.

Royal Arch Reaffirmation Day:

This day is not just a religious observance. It is meant to reaffirm our vows to both God and Capitular Masonry and to memorialize the formation of the Grand Chapter of Ohio on October 24, 1816. This event should not be

viewed as a mandated obligatory observance, but a joyous occasion of fellowship and celebration of our beloved Capitular Rite.

Why Affirmation Day? “Because we seek to thank God for bringing together all the Grand Chapters of the world into an International General Grand Chapter on October 24, 1816. Therefore we join our hearts together throughout the world as Royal Arch Masons on the nearest Sunday in October to that date in the spirit of reaffirmation of our solemn vows to Almighty God for his revelation of Divine Truth given us through Masonry.” Constituent Chapters are requested to attend the religious services of their choice, as a group if possible, on Reaffirmation Sunday on the closest Sunday to October 24th as practical.

Royal Arch Research Assistance supports two charities:

Central Auditory Processing Disorder

Central Auditory Processing Disorder (or CAPD) is a hearing deficiency that usually affects younger people and does not allow them to distinguish sounds as would be heard by those with regular hearing. Background noises and other speakers disturb and confuse people with CAPD making it difficult to concentrate. This results in misunderstanding and/or frustrations leading to students being accused of being dysfunctional. Often students with satisfactory IQ's produce substandard work because they cannot hear messages or a teacher's delivery clearly. Research is developing paths of opportunity to correct this problem and RARA contributions support these research efforts. Our activities go back over 30 years and much progress has been achieved through these efforts. More needs to be done and that is why RARA has expanded their efforts.

Autism Speaks

Autism strikes 1 in 110 births and 1 in 70 boy births so it is a major problem in the world today. Autism Speaks has become very well known throughout the country as they strive to help the more and more children that are diagnosed with this problem. The challenge in this area goes much deeper than children and their parents who are provided with special training in dealing with this difficulty, but becomes increasingly difficult for parents as they become older and plans must be made for the days when those parents will no longer be able to provide the care and support needed. Our activity with this highly visible organization should benefit both immeasurably. Royal Arch Masons will be able to participate in the more than 90 “Walks”

around the country, challenging greater contributions and making Royal Arch Masons visible doing good works in the community. This clearly shows that RARA continues to do what it does best, to support and fund research for its core charity and mission – CAPD! We are proud of that record and its consistent and continued commitment.

Change:

Section 3-12 RECORDER

(I) To transmit to the Grand Recorder by no later than January 15, of each year its Annual Returns, in such form as shall be prescribed by the Grand Chapter, covering the immediately preceding period January 1st to December 31st, both inclusive, together with all sums due the Grand Chapter.

Be it resolved to amend the By-laws 2-27 AMENDMENTS to read as follows

Section 2-27 AMENDMENTS

All proposed amendments to the Laws relating to Grand Chapter shall be submitted in writing to the Grand Secretary at least forty five days before the next Annual Convocation. At least THIRTY FIVE days before such Annual Convocation of Grand Chapter the Grand Secretary shall transmit to the Grand Officers, Past Grand Elected Officers and Secretaries of the several constituent Chapters of this jurisdiction, and to the members of the Jurisprudence Committee of Grand Chapter, copies of any such proposed amendments.

All proposed amendments shall first be referred to the Committee on Jurisprudence for its opinion and report. Any proposed amendment, ruled

by the Committee on Jurisprudence to be "not" in proper form, shall not be placed upon the floor of the Annual Convocation of the Grand Chapter, for vote, until said amendment shall have been put in proper form. Responsibility for "Proper Form" shall be with the author of the amendment.

The Committee on Jurisprudence shall advise the author, or authors, of proposed amendments, prior to the Annual Convocation, if such amendments are "not in proper form". If the amendment is then approved in Annual Convocation by a majority of the votes, then such amendment shall become effective. Grand Chapter may suspend the forgoing provisions by two-thirds vote at the Annual Convocation or a Special Convocation called for such Purpose.

CHANGE LAST PARAGRAPH TO READ:

The Committee on Jurisprudence shall advise the author, or authors, of proposed amendments, prior to the Annual Convocation, if such amendments are "not in proper form". After "proper form" is satisfied, if the amendment is then approved in Annual Convocation by a majority of the votes, then such amendment shall become effective. Grand Chapter may suspend the forgoing provisions by two-thirds vote at the Annual Convocation or a Special Convocation called for such Purpose.

And Whereas, Utah is a small jurisdiction averaging around 300 Companions, and it is often difficult to get a requisite number of Companions present in order to meet Section 3-5 QUORUM in order to open and conduct business.

Let it be resolved to amend the Constitution of the Grand Chapter of Utah, Royal Arch Masons, Section 3-5 to allow 5 or more members of a Chapter to open in order to conduct the business of the Chapter.

Current Constitution of the Grand Chapter of Utah, RAM.

Section 3-5 Quorum reads, “A quorum of a Chapter consists of nine (9) members entitled to vote therein, including an Officer authorized to open the same.”

The Change to Section 3-5 Quorum would read as follows,

Section 3-5 Quorum

A quorum of a Chapter consists of five (5) members entitled to vote therein, including an officer authorized to open the same, for the purpose of conducting business. A Chapter that is being formed, or conferring the degrees would require nine (9) members entitled to vote and an officer entitled to open the same to meet the quorum requisite.

Every Council I visited, although using the ritual book, seemed dependent upon it. I would strongly urge every Companion to study the ritual and memorize it for opening and closing as you have done for your Blue Lodges. For Past Illustrious Masters, your experience and guidance are continually needed, and I would strongly urge you keep attending. Your experience is invaluable to the future of the York Rite.

A few of the Councils I visited were a bit shorthanded of members on that night. I would urge councils to get phone trees going or create shared calendars for all the members to see so they can remember what night York Rite is meeting on. Call Companions that have not attended in a while to check up on them and invite them to events.

Unfortunately, due to the outbreak the Council festival that was meant to be held in Ogden on March. 28th was cancelled. Hopefully, we can get this rescheduled for this fall and have the chance to show our beautiful ritual once again to a new group of Companions.

There are a few suggestions I have for the Council. First, I would suggest that we not allow the use of a ritual book during ritual including opening and closing of a Council except for designated prompters during a degree. Second, hold more events other than business meetings to keep the Companions engaged. Third, I would strongly urge every Council to adopt the new ritual book available through the Grand Secretary/Recorder as their primary ritual guide. Lastly, hold mockup degrees/practices frequently. This will keep the ritual fresh in our minds and improve our ritual overall. The Council degrees offer deep lessons that warrant plenty of contemplation.

SECTION 3-12 RECORDER

Whereas the Constituent Councils work on a calendar year and dues are collected for said calendar year.

And whereas Recorders are required to submit the annual returns based on the prescribed Grand Chapter requirements of April 1 to March 31.

And whereas this difference in operating and reporting causes confusion in the data collected and reported to the General Grand Council of Cryptic Masons.

Be it resolved to amend the By-laws **3-12 Recorder** to read:

Current:

Section 3-12 RECORDER

(I) To transmit to the Grand Recorder by no later than April 10, of each year its Annual Returns, in such form as shall be prescribed by the Grand Council, covering the immediately preceding period April 1st to March 31st, both inclusive, together with all sums due the Grand Council.

Change:

Section 3-12 RECORDER

(I) To transmit to the Grand Recorder by no later than January 15, of each year its Annual Returns, in such form as shall be prescribed by the Grand Council, covering the immediately preceding period January 1st to December 31st, both inclusive, together with all sums due the Grand Council.

SECTION 3-5 QUORUM

Whereas the Constitution of the Grand Council of Utah, Cryptic Masons, Section 3-5 QUORUM; identifies the number of members of a Constituent Council that must be present to open a Council.

And Whereas, Utah is a small jurisdiction averaging around 300 Companions, and it is often difficult to get a requisite number of Companions present in order to meet Section 3-5 QUORUM in order to open and conduct business.

Let it be resolved to amend the Constitution of the Grand Council of Utah, Cryptic Masons, Section 3-5 to allow 5 or more members of a Council to open in order to conduct the business of the Council.

Current Constitution of the Grand Council of Utah, Cryptic Masons. Section 3-5 Quorum reads, "A quorum of a Council consists of nine (9) members entitled to vote therein, including an Officer authorized to open the same."

The Change to Section 3-5 Quorum would read as follows,
Section 3-5 Quorum

A quorum of a Council consists of five (5) members entitled to vote therein, including an officer authorized to open the same, for the purpose of conducting business. A Council that is being formed, or conferring the degrees would require nine (9) members entitled to vote and an officer entitled to open the same to meet the quorum requisite.
