### GRAND TREASURER'S REPORT

Sir Knights and Companions,

Aside from having a new Treasurer, there are some nuances from past reports.

First, thanks to COVID it took quite an effort to acquire all the regalia, (Aprons, Jewels, etc.) inventory, and then work to get them out to the new officers. The latter part was not 100% completed and I still have about 5-6 Apron/Jewel cases at home. Given that we're still being affected by the pandemic, it has probably saved me a little time from starting the process over again.

Merrill Lynch now requires a minimum investment of \$250,000 and as such they cancelled our account and refunded our monies in the amount of \$86,661.48 to our checking held with Mountain America Credit Union. \$75,000 of that was used to start a new investment with Baird Financial.

Due to past confusion with Grand Encampment, it has been discovered that our operating budget should be based on calendar year instead of an April to March fiscal year. As such, I will provide income and balance numbers for both end of calendar year and end of fiscal year to help lessen the confusion.

Jenafer Dunn has played a vital role in setting up and reconciling our accounts in Quick Books. Huge thank you goes out to her in helping me with that portion of responsibility. I hope I can continue her meticulous attention to detail.

Thanks to our Finance Committee, we have working capital in our checking account and an operating budget for ensuing year. Currently we are only using one checking bucket with Mountain America for all three Grand York Rite bodies. I did have 3 separate sub-accounts created for each body if we wish to separate each body into their own checking. That would mean we keep three separate checkbooks instead of one, as we have historically done. Also, given that some of our available working balance came from Merrill Lynch, I would recommend the Finance Committee define a clear starting reference for each body/bucket, either by giving each a percentage or a base balance.

**REPORT OF THE GRAND SECRETARY/RECORDER**

As last year your Grand Secretary/Recorder continued the responsibilities during this unprecedented time. Although all events and meetings have been cancelled, I did have the opportunity to attend the 2020 Southwest Regional Conference by Zoom this past year.

With the continuation of only Zoom meetings due to COVID 19, numerous housekeeping items have been followed up on from the last year.

- **QuickBooks** – Our Grand Treasurer has taken on QuickBooks to handle all the financials along with having a goal to break out the finances for Grand Chapter, Grand Council and Grand Commandery, since this is the right thing to do.
- **Fiscal Year** – 2020 aligned with the Calendar year to reflect Grand Encampment calendar year.
- **MMS** – The local Body Secretary/Recorders have continued to keep up with the records for their Commandery, Chapters and Councils. This has been a major undertaking, which if continued will provide accurate membership accounting.
- **2022 Time & Place** – Final decision has not been made for the 2022 Grand York Rite venue.
- **Investment Fund:** The Grand York Rite Investment Fund has been set-up with Baird.
- **Annual Return Assessments:** All Local Bodies have sent in the 2020 Annual Returns.
- **ZOOM Pro Account:** The yearly subscription is still active. This is a great tool to utilize to set-up Committee Meetings, Grand Bodies meetings. One suggestion I would recommend is for the Grand Body

Officers to take advantage to start up Quarterly meetings. I would also encourage the Finance Committee to at minimum conduct Quarterly meetings to review the financial health of the Grand York Rite.

- **Grand Chapter Name Badges:** The Finance Committee this year has clarified what is provided and costs involved.
- **State Awards:** Unlike the prior year, there has been a significant focus on State and General Bodies. This past year the Grand Heads have made it a priority to award those Companions/Sir Knights for their service to the Utah York Rite.
- **KTCH Grand Encampment Award:** All Companions/Sir Knights should be pleased to know unlike last year this very high honor was not missed this year.

## **FINANCE COMMITTEE**

Your Finance Committee have been meeting via Zoom to establish a discuss our investments and establish a budget.

Our investment funds have been with Merrill Lynch, but it seemed like the amount we had to invest was a smaller amount than they would prefer to work with. Other Utah Masonic Bodies including the Grand York Rite Trust has had funds invested with Baird with good results. A decision was made to open an account and invest with Baird. We discussed investment strategies with the Baird and our goal is to have some growth and income but in some investments that were reasonably stable. Baird has provided an investment strategy to accomplish these goals. A copy of the investment strategy is included in this report which provides more detail. We now have approximately \$75,000 invested with Baird.

We have not had a budget for a few years, so we did not have a lot of past data to work with. However, with the assistance of Jenafer Dunn, Marty Martineau, David Read, Kelly Allred and others it is a start and is a work in progress. We task the ongoing financial committee to continue this work and fine tune and improve the budget as time goes on. (see group sections for applicable budget)

You will note that there is a net loss of \$2,647.27. We hope to cover this with earnings from our investments until such time as we have funds coming in from other sources. More members will help with this, so we all need to work on getting new qualified members. This is not only to raise funds but to be able for our York Rite Bodies not only to exist but to thrive.

Grand Sessions will be in person next year and it is our goal to at least break even and possibly come out slightly ahead. In the past we have provided complimentary meals and expenses for too many visitors. Our policy now is to only provide complimentary expenses for only those dignitaries that we should provide for. Our goal is to have a quality Grand Sessions but also to minimize expenses where we can. The Time and Place Committee has already started meeting to work out the details.

## **OFFICER'S REPORTS**

### **REPORT OF THE MOST EXCELLENT GRAND HIGH PRIEST**

I welcome you to the 110th Annual Convocation of this Grand Chapter. I would like to thank our visitors who are visiting from near and far via Zoom. You honor us with your presence.

As per the Grand Chapter Constitution, I now present to you my report of this past year, with official acts and decisions that I initiated during our recess. I will also report on the state and condition of Royal Arch Masonry in Utah and my recommendations. Per the custom of this Grand Chapter and to keep the report reasonable in length, those parts deemed to be less relevant are appended here to.

#### **State and Condition of the Chapter**

The foundation laid One Hundred Ten years ago is as sound today as it was then. Our Grand Chapter Constitution and Ritual, although tweaked here and there have withstood the test of time. For the most part our Chapters are performing at a level to meet the expectations of the Fraternity.

The Grand York Rite of Utah has always looked to the future when it comes to technology and this pandemic year has been no exception. With the decision to close the Chapters to in person meetings due to the pandemic, Zoom became the way to meet and keep the light of Capitular Masonry alive and working. This platform has created a number of benefits that would not have been possible under the normal face to face meeting. For example, it allows members from all over the world to meet together and discuss or learn about Freemasonry.

The Zoom platform was used to visit with all of the Local Chapters over the year. In addition, Companion Reed Fanning the Most Illustrious Grand Master arranged for an educational as part of each visitation. These educationals were presented by speakers from all over the country and were very well received, so well in fact the General Grand Council has picked up the idea and enlisted Companion Fanning to continue with the educationals under their banner. I would like to thank Companions Danny Drew and Jason Varner for all of the help they gave and continue to give in making these educationals a huge success. I believe this venue has many uses in the future to help officers of a body hold more planning meetings, Grand Bodies to hold leadership conferences and possibly even quarterly meetings in addition to our Annual Sessions.

My Companions as great as the Zoom technology is, it isn't Masonry, and we should not try to replace our face-to-face meetings with Zoom meetings. Our beloved Fraternity with its teachings and all of the things that go with them work so much better when you can look a Brother in the eye and see the genuine delight of being together with like-minded men. The pandemic has shown us how important human contact is for the health of our society and I believe for the prosperity of the Craft.

Companions, my Decisions and Dispensations are attached, but I would like to address one in particular. Covid 19 has turned our world upside down and it has created challenges and concerns for leaders in every organization and in every government. Each having the same goal to protect the health and well-being of its members, employees or citizens. I was no different in my concern for my Brothers.

Companions there are two kinds of Masonry. No, I am not referring to the operative or speculative as you might be thinking. The first is much older than our Chapters or rituals. Older than many of the events described in the fables written about the antiquity of the craft. It is a part of every religion over the history of mankind. Every Prophet, Sage, Seer and Philosopher who has worked to improve the fate of man has used this important element in their teachings. Some call it that religion on which all men agree. The universal religion of which Micah in the Old Testament spoke "and what doth the Lord require of thee, but to do justly, and to love mercy, and to walk humbly with thy god?" In our own ritual that charges us with. "To God, in

never mentioning his name but with a reverential awe which is due from a creature to his creator; to implore his aid in all your laudable undertaking and esteem him as the chief good. To your neighbor, in acting upon the square and doing unto him as you wish that he should do unto you”

This is pure Masonry and is the foundation of our ritual. These ancient lessons, these tried-and-true precepts in a world that appears to have lost its moral compass, are a powerful force which continues to attract good men to our Fraternity. To the degree we practice pure Masonry our communities become better places to live.

The second type is institutional Masonry. It includes the way we organize our Chapters, our Grand Chapter, our committees, our officers, and our activities. In short, all the things we do to accomplish our ideals. Institutional Masonry for most of us here today, occupies most of our time and energy.

All of us here today are dedicated to the first kind but are deeply involved in the second. I can't help but wonder at times, if we become so deeply intertwined in the details of our Brotherhood, that we lose sight of our ideals. Is it possible that our very own organizational structure gets in our way, preventing us from accomplishing our goals? I believe many of the problems that we agonize over and put so much energy into solving are doing just that.

There have been hundreds of books published, telling us what we need to do, and how to do it. The results at best have been short lived. Most Chapters would be happy if 20% of their members regularly attended their meetings. This is very difficult for those of us who are heavily involved in the work of the Chapter to understand. Why aren't the majority of our members as attracted to the work of the craft as we are? We have geared ourselves to the making of new members, rather than to the interest and needs of those who are already members.

There is one aspect to attendance that has to do with what we promise and what we deliver. Pure Masonry versus Institutional Masonry, if you will. There is no need for me to remind any one of you present about the nature of the obligations which bind us together, and yet, I am always amazed at the number of members who have for years had no contact with the Chapter, other than the exchange of a check and a dues card. Which of us has not been

embarrassed when sitting in a meeting and we hear about the death of a Brother several months or even a year or more after the sad event! What a sad comment on the quality of our Fraternal ties. I have heard it said, "Masonry isn't what it used to be." I ask, "When did Masonry change?" My Companions, is it not we who are not what we used to be? How long has it been since you rededicated yourself to your Masonic pledges and honored ideals?

We can continue to look for that magic solution or we can get back to the true work of building one Mason at a time. It all comes down to our choices. I would like to read you a story from *Memorabilia circa 371 BC*, entitled "The Choice of Hercules".

When Hercules was in that part of his youth in which it was natural for him to consider what course of life he ought to pursue, he one day retired into a desert, where the silence and solitude of the place very much favored his meditations.

As he was musing on his present condition, and very much perplexed in himself, on the state of life he should choose, he saw two women of a larger stature than ordinary, approaching towards him. One of them had a very noble air, and graceful deportment; her beauty was natural and easy, her person clean and unspoiled, her motions and behavior full of modesty, and her gown was white as snow. The other wanted all the native beauty and proportion of the former; her person was swelled, by luxury and ease, to a size quite disproportioned and uncomely.

She had painted her complexion, that it might seem fairer and rosier than it really was and endeavored to appear more graceful than ordinary in her bearing, by a mixture of affection in all her gestures. She cast her eyes frequently upon herself, then turned them on those that were present, to see whether anyone regarded her, and now and then looked on the figure she made in her own shadow.

As they drew nearer, the former continued the same composed pace, while the latter striving to get before her, ran up to Hercules, and addressed herself to him:

“My dear Hercules,” says she, “I find you are very much divided in your thoughts, upon the way of life that you ought to choose; be my friend and follow me; I will lead you into the possession of pleasure, and out of the reach of pain, and remove you from all the noise and disquietude of business. The affairs of either peace or war, shall have no power to disturb you. Your whole employment shall be to make your life easy, and to entertain every sense with its proper gratifications. Sumptuous tables, beds of roses, clouds of perfumes, concerts of music, crowds of beauties, are all in readiness to receive you. Come along with me into this region of delights, this world of pleasure, and bid farewell forever, to care, to pain, to business.”

Hercules, hearing the lady talk after this manner, desired to know her name; to which she answered, “My friends, and those who are well acquainted with me, call me Happiness; but my enemies, and those who would injure my reputation, have given me the name of Pleasure.”

By this time the other lady came up, who addressed yourself to the young hero in a very different manner.

“Hercules,” says she, “I offer myself to you, because I know you are descended from the gods, and give proofs of that descent by your love to virtue, and application to the studies proper for your age. This makes me hope you will gain, both for yourself and me, an immortal reputation. But, before I invite you into my society and friendship, I will be open and sincere with you, and must lay down this, as an established truth, that there is nothing truly valuable which can be purchased without pains and labor. The gods have set a price upon every real and noble pleasure. If you would gain the favor of the Deity, you must be at the pains of worshiping him: if the friendship of good men, you must study to oblige them: if you would be eminent in war or peace, you must become master of all the qualifications that can make you so. These are the only terms and conditions upon which I can propose happiness.”

The goddess of Pleasure here broke in upon her discourse: “You see,” said she, “Hercules, by her own confession, the way to her pleasures is long and difficult; whereas that which I propose is short and easy.” “Alas!” Said the other lady, whose visage glowed with passion, made up of scorn and pity, “What are the pleasures you propose? To eat before you are hungry, drink

before you are athirst, sleep before you are tired; to gratify your appetites before they are raised. You never heard the most delicious music, which is the praise of one's own self; nor saw the most beautiful object, which is the work of one's own hands. Your disciples pass away their youth in a dream of mistaken pleasures, while they are hoarding up anguish, torment, and remorse, for old age."

"As for me, I am the friend of gods and of good men, an agreeable companion to the artisan, a household guardian to the fathers of families, a patron and protector of servants, an associate in all true and generous friendships. The banquets of my disciples are never costly, but always delicious; for none eat and drink at them, who are not invited by hunger and thirst. Their slumbers are sound, and their waking's cheerful. My young men have the pleasure of hearing themselves praised by those who are in years; and those who are in years, of being honored by those who are young. In a word, my followers are favored by the gods, beloved by their acquaintance, esteemed by their country, and after the close of their labors, honored by posterity."

Companions we all joined to be a part of something bigger than ourselves. Let us set aside our egos and take off the aprons of distinction and put back on the aprons of service to our beloved Fraternity!

**Recommendations:**

This Grand Chapter create a Grand High Priest Chapter for those Companions who are NPD to be placed in so that they can be contacted and worked with to bring them back into the fold.

This Grand Chapter create the legislation necessary to create a traveling Grand Royal Arch Chapter to serve those areas where there are Blue Lodges but no York Rite bodies.

This Grand Chapter create regional education teams to help the Blue Lodges in the area deliver quality educationals and improve the quality of the experience.

This Grand Chapter hold leadership workshops both in person and via Zoom at least quarterly.

This Grand Chapter develop ideas and programs with the aid of the York Rite Trust to enhance and promote Capitular Masonry here in Utah.

I would like to thank Companions Jay Mitchell and Reed Fanning for their support and all of the hard work they have and continue to do on behalf of the Grand York Rite of Utah. I Learned so much from both of you and our friendship has grown even more, it was an honor and privilege to work with you. I would also like to thank my lady Nancy who always puts me first and without all the love and support she so generously gives I could not do half the things I love doing. She is truly the driving force in our family!!!

My Companions I want to thank you for having faith in me to be able to lead this Grand Chapter, it is always a humbling experience for me.

## **LEGISLATION**

Proposal #1

### **Proposed Amendment to the Constitution of the Grand Chapter of Royal Arch Masons of Utah**

WHEREAS, Section 2-8 (A) Standing Committees states; Before each Annual Convocation adjourns, or within thirty-days thereafter, the Grand High Priest elected at such Annual Convocation, shall appoint the following Standing Committees:

Committee on Masonic Jurisprudence  
Committee on Finance

Committee on Grievance and Appeals  
Committee on Education  
Committee on Fraternal Relations  
Committee on Triennial Convocation  
Committee on Utah York Rite Education Fund  
Committee on Annual York Rite Sessions

Each Committee shall consist of three or more members and the first named shall be the Chairman and shall serve for one year or until their successors have been appointed. Any recommendations made by either Standing or Special Committees that necessitate a change of the rules, regulations, operations or finances shall be handled in the same time frame and manner as for proposals etc.. ; and

WHEREAS Section 2-9 (B) FINANCE states; The finance committee shall be a Joint Standing Committee of at least four (4) in number including a chairman. With one of the four being elected annually to a four-year term. The election of this member shall be determined by a majority vote of the delegates present, held during the Joint portion of the Grand York Rite sessions. The initial term will be determined by elections of one each 1-year, 2-year, 3-year and 4-year members. The Grand High Priest, Grand Illustrious Master and Grand Commander will be an added part of this committee. The purpose of the committee is to manage the funds of the Grand York rite Bodies. The actions of this committee shall be determined by majority vote of the finance committee. The ballots are to be counted as one person, one vote. The Grand Secretary-Recorder and Grand Treasurer will be ex-officio members for the purpose of record keeping, minutes, and information with no power to vote on actions of the finance committee.; and

WHEREAS Section 2-8 and Section 2-9 are in conflict with each other concerning how members of the Finance Committee are chosen.; and

WHEREAS Section 2-9 (B) is more specific in the make-up and duties of the Finance Committee.

BE IT THEREFORE RESOLVED that Section 2-8 (A) be amended as follows:

B. Finance Committee be removed, and the standing committees be re-lettered A thru G.

PROPOSAL #2

**Proposed Amendment to the Constitution of the Grand Chapter of Royal Arch Masons of Utah.**

WHEREAS Section 2-9 (B) FINANCE states; The finance committee shall be a Joint Standing Committee of at least four (4) in number including a chairman. With one of the four being elected annually to a four-year term. The election of this member shall be determined by a majority vote of the delegates present, held during the Joint portion of the Grand York Rite sessions. The initial term will be determined by elections of one each 1-year, 2-year, 3-year and 4-year members. The Grand High Priest, Grand Illustrious Master and Grand Commander will be an added part of this committee. The purpose of

the committee is to manage the funds of the Grand York rite Bodies. The actions of this committee shall be determined by majority vote of the finance committee. The ballots are to be counted as one person, one vote. The Grand Secretary-Recorder and Grand Treasurer will be ex-officio members for the purpose of record keeping, minutes, and information with no power to vote on actions of the finance committee.

They may by majority vote appoint a duly qualified outside financial advisor or financial institution for suggestions and advice. The finance committee shall hold and take title to all of the assets and funds of the Grand Chapter, Grand Council and Grand Commandery, with the exception of those funds held by the York Rite of Utah Foundation. They may co-mingle them, as long as they are spread on the books individually, as part of the Grand York Rite Funds except the general operating funds. They may loan and invest funds in such manner as the Grand Chapter, and/or Grand Council, and/or Grand Commandery may request from time to time, or in the absence of such specific direction, to the best of their judgement and ability in securities generally accepted by the Trust department of sound financial institutions. This may include but not limited to United States Government Bonds, Treasury Bills, or other certificate of indebtedness, State and Municipal Bonds, Savings Accounts and Certificates and Corporate Bonds and Mutual Funds. A portion of these investments should be available in a timely manner transferable to pay the indebtedness of the Grand Chapter, Grand Council and Grand Commandery.

All actions taken by the Finance Committee shall be governed by the prudent man rule and with agreement of the majority. In case of a deadlock the duty shall fall to the Chairman for decisions.

They shall reinvest the interest and dividends or deposit to the General Fund amounts needed as circumstances warrant. They shall make a complete and detailed report of all assets and funds in their possession

at each Annual Sessions, and shall annually audit the books of the Grand Recorder and Grand Treasurer, and shall certify their findings at the Joint Portion of the Annual Grand York Rite Sessions.

They will also prepare and submit a budget for the ensuing year for each Grand York Rite body for action at the annual sessions.

Any item or items not covered herein shall be governed by the requirements of the Code and Trial Code of the Grand Lodge F. & A.M. of Utah and Masonic usage.; and

WHEREAS there is no roll call taken or credentials report given.; and

WHEREAS there is no way of knowing who the eligible delegates to vote are without a credentials report and roll call.

BE IT THEREFORE RESOLVED that Section 2-9 (B) Finance be amended as follows:

First paragraph; The Finance Committee shall be a Joint Standing Committee of at least four (4) in number including a chairman. With one of the four being elected annually to a four-year term. The election of this member shall be determined by a majority vote of the delegates present, held in the first body to open per Section 2-3 Convocation (B) where a credentials report and roll call is taken to establish the eligible delegates. The initial term will be determined by elections of one each 1-year, 2-year, 3-year and 4-year members. The Grand High Priest, Grand Illustrious Master and Grand Commander will be an added part of this committee. The purpose of the Committee is to manage the funds of the Grand York Rite Bodies. The actions of this committee shall be determined by majority vote of the finance committee. The ballots are to be counted as one person, one vote. The Grand Secretary-Recorder and Grand Treasurer will be ex-officio members for the purpose of record keeping, minutes, and information with no power to vote on actions of the finance committee.

WHEREAS, Section 1-7 ASSESSMENTS states; It shall possess authority to require from the several Chapters within its jurisdiction, such proportion of the sums received by them for conferring the degrees, and also sums in the form of annual dues from the respective members, as may be necessary for the support of the Grand Chapter.; and

WHEREAS, Section 2-19 FINANCES states; Each Chapter may set their dues and fees as prescribed by the membership, in their By-laws, provided such dues and fees shall not be less than the annual per capita due the Grand Chapter. The dues and fees of Chapter having concurrent jurisdiction need not be the same.

The revenue of the Grand Chapter shall be derived from fees and dues charged as follows:

- (A) For a Dispensation to form a New Chapter, Forty-Five (\$45.00) Dollars and for a new Charter Ten (\$10.00) dollars.
- (B) For each Mason exalted, Two Dollars (\$2.00) to be paid by the Chapter of which the candidate receiving the Degree shall thereupon become a member, provided that no fee shall be due the Grand Chapter for courtesy work done for Chapters outside of Utah.
- (C) Each Constituent Chapter shall remit to the Grand Chapter, at the time of making the Annual Returns, the assessed dues for each Companion who was a member at the close of the fiscal year. For current amount, refer to the last date on this subject in TITLE V Standing Resolutions.
- (D) For the Triennial Fund, the assessed amount, on the latest date as referred to in TITLE V Standing Resolutions.
- (E) Such special assessments and fees as the Grand Chapter shall levy.; and

WHEREAS, The General Grand Chapter Triennial Convocation is held after our annual Convocation; and

WHEREAS, should a per capita increase or decrease be approved at the Triennial. Such increase or decrease becomes affective before our next Convocation; and

WHEREAS, This increase or decrease would affect our budget; and

WHEREAS, TITLE V STANDING RESOLUTIONS MAY 2015 PER CAPITA states; It was proposed and approved by majority vote to increase per-capita by \$1.00 for the years 2016 and 2017 for a total per-capita of \$6.00 THEN, increase the per-capita beginning in the year 2018 by an additional \$1.00 for a total per-capita at that time of \$7.00 (Utah portion \$4.00 and General Grand Chapter portion \$3.00); and

WHEREAS, The Utah portion has not been sufficient to cover the expenses of the Grand Chapter. Causing the Grand Chapter to pull or seek funds from other accounts; and

WHEREAS, No organization can survive running an annual deficit;

BE IT THEREFORE RESOLVED that a MAY 2021 STANDING RESOLUTION be added to TITLE V STANDING RESOLUTIONS: The annual per-capita be raised as follows:

The Utah portion raised by \$3.00 to \$7.00 plus + General Grand Chapter per-capita fees (currently \$3.00) for a total per-capita of \$10.00.

It is our decision that all constituent Chapters of the Grand Chapter Royal Arch Masons of Utah and all Cryptic Councils of the Grand Council of Cryptic Masons in Utah remain closed until January 1, 2021 or until this order is rescinded by the respective heads of the same.

Meetings are encouraged and may continue to take place via video conferencing. We wish you all the best and ask that you stay safe and healthy. Continue to practice brotherly love and charity. Check in on our companions to ensure their wellbeing and welfare are attended to.”

Decision 20/21-3 (11 Apr 2021) Sessions: This decision must be read in all York Rite Bodies within the Jurisdiction and shall become effective as of the date of this letter.

Whereas, Covid-19 has caused us for the safety of our members to meet virtually throughout the year; and,

Whereas Section 2-3 States the Annual Sessions of the Grand York Rite Bodies of Utah will convene on the Second Friday and the following Saturday in May; and

Whereas Section 2-4 states that “Special Convocations, Assemblies and Conclaves may be called by the Grand High Priest, Grand Illustrious Master and Grand Commander whenever the welfare of the craft shall require it.

It is therefore our decision that the 2021 Grand York Rite Sessions be held virtually on May 8, 2021, starting at 9:00 am with the Joint Sessions.

**Proposed Amendment to the Constitution of the Grand Council of Utah, Cryptic Masons.**

WHEREAS, Section 2-8 (A) Standing Committees states; Before each Annual Convocation adjourns, or within thirty-days thereafter, the Grand Illustrious Master elected at such Annual Assembly, shall appoint the following Standing Committees:

- Committee on Masonic Jurisprudence
- Committee on Finance
- Committee on Grievance and Appeals
- Committee on Education
- Committee on Fraternal Relations
- Committee on Triennial Assembly
- Committee on Utah York Rite Education Fund
- Committee on Annual York Rite Sessions

Each Committee shall consist of three or more members and the first named shall be the Chairman and shall serve for one year or until their successors have been appointed. Any recommendations made by either Standing or Special Committees that necessitate a change of the rules, regulations, operations or finances shall be handled in the same time frame and manner as for proposals etc..; and

WHEREAS, Section 2-9 (B) FINANCE states; The finance committee shall be a Joint Standing Committee of at least four (4) in number including a chairman. With one of the four being elected annually to a four-year term. The election of this member shall be determined by a majority vote of the delegates present, held during the Joint portion of the Grand York Rite sessions. The initial term will be determined by elections of one each 1-year, 2-year, 3-year and 4-year members. BE IT THEREFORE RESOLVED that Section 2-8 (A) be amended as follows:

B. Finance Committee be removed and the standing committees be re-lettered A thru G.

Proposal #2

**Proposed Amendment to the Constitution of the Grand Council of Cryptic Masons of Utah.**

WHEREAS, Section 2-9 (B) FINANCE states; The finance committee shall be a Joint Standing Committee of at least four (4) in number including a chairman. With one of the four being elected annually to a four-year term. The election of this member shall be determined by a majority vote of the delegates present, held during the Joint portion of the Grand York Rite sessions. The initial term will be determined by elections of one each 1-year, 2-year, 3-year and 4-year members. The Grand High Priest, Grand Illustrious Master and Grand Commander will be an added part of this committee. The purpose of the committee is to manage the funds of the Grand York rite Bodies. The actions of this committee shall be determined by majority vote of the finance committee. The ballots are to be counted as one person, one vote. The Grand Secretary-Recorder and Grand Treasurer will be ex-officio members for the purpose of record keeping, minutes, and information with no power to vote on actions of the finance committee.

They may by majority vote appoint a duly qualified outside financial advisor or financial institution for suggestions and advice. The finance committee shall hold and take title to all of the assets and funds of the Grand Chapter, Grand Council and Grand Commandery, with the exception of those funds held by the York Rite of Utah Foundation. They may co-mingle them, as long as they are spread on the books individually, as part of the Grand York Rite Funds except the general operating funds. They may loan and invest funds in such manner as the Grand Chapter, and/or Grand Council, and/or Grand Commandery may request from time to time, or in the absence of such specific direction, to the best of their judgement and ability in securities generally accepted by the Trust department of sound financial institutions. This may include but not limited to United States Government Bonds, Treasury Bills, or other certificate of

indebtedness, State and Municipal Bonds, Savings Accounts and Certificates and Corporate Bonds and Mutual Funds. A portion of these investments should be available in a timely manner transferable to pay the indebtedness of the Grand Chapter, Grand Council and Grand Commandery.

All actions taken by the Finance Committee shall be governed by the prudent man rule and with agreement of the majority. In case of a deadlock the duty shall fall to the Chairman for decisions.

They shall reinvest the interest and dividends or deposit to the General Fund amounts needed as circumstances warrant. They shall make a complete and detailed report of all assets and funds in their possession at each Annual Sessions, and shall annually audit the books of the Grand Recorder and Grand Treasurer, and shall certify their findings at the Joint Portion of the Annual Grand York Rite Sessions.

They will also prepare and submit a budget for the ensuing year for each Grand York Rite body for action at the annual sessions.

Any item or items not covered herein shall be governed by the requirements of the Code and Trial Code of the Grand Lodge F. & A.M. of Utah and Masonic usage.; and

WHEREAS, there is no roll call taken or credentials report given. ; and

WHEREAS, there is no way of knowing who the eligible delegates to vote are without a credentials report and roll call.

BE IT THEREFORE RESOLVED that Section 2-9 (B) Finance be amended as follows:

First paragraph; The Finance Committee shall be a Joint Standing Committee of at least four (4) in number including a chairman. With one of the four being elected annually to a four-year term. The election

of this member shall be determined by a majority vote of the delegates present, held in the first body to open per Section 2-3 Assembly (B) where a credentials report and roll call is taken to establish the eligible delegates. The initial term will be determined by elections of one each 1-year, 2-year, 3-year and 4-year members. The Grand High Priest, Grand Illustrious Master and Grand Commander will be an added part of this committee. The purpose of the Committee is to manage the funds of the Grand York Rite Bodies. The actions of this committee shall be determined by majority vote of the finance committee. The ballots are to be counted as one person, one vote. The Grand Secretary-Recorder and Grand Treasurer will be ex-officio members for the purpose of record keeping, minutes, and information with no power to vote on actions of the finance committee.

Proposal #3

### **Proposed Amendment to the Constitution of the Grand Council Cryptic Mason of Utah**

WHEREAS, Section 1-7 ASSESSMENTS states; It shall possess authority to require from the several Councils within its jurisdiction, such proportion of the sums received by them for conferring the degrees, and also sums in the form of annual dues from the respective members, as may be necessary for the support of the Grand Council.; and

WHEREAS, Section 2-19 FINANCES states; Each Council may set their dues and fees as prescribed by the membership, in their By-laws, provided such dues and fees shall not be less than the annual per capita due the Grand Council. The dues and fees of Council having concurrent jurisdiction need not be the same.

## Grand Council Cryptic Masons of Utah

The revenue of the Grand Council shall be derived from fees and dues charged as follows:

- (A) For a Dispensation to form a New Council, Fifty (\$50.00) Dollars.
- (B) For each Royal and Select Degree conferred, Two Dollars (\$2.00) to be paid by the Council of which the candidate receiving the Degree shall thereupon become a member, provided that no fee shall be due the Grand Council for courtesy work done for Councils outside of Utah.
- (C) Each Constituent Council shall remit to the Grand Council, at the time of making the Annual Returns, the assessed dues for each Companion who was a member at the close of the fiscal year. For current amount, refer to the last date on this subject in TITLE V Standing Resolutions.
- (D) For the Triennial Fund, the assessed amount, on the latest date as referred to in TITLE V Standing Resolutions.
- (E) Such special assessments and fees as the Grand Council shall levy.; and

WHEREAS, The General Grand Council Triennial Assembly is held after our annual Assembly.; and

WHEREAS, should a per capita increase or decrease be approved at the Triennial. Such increase or decrease becomes affective before our next Assembly.; and

WHEREAS, This increase or decrease would affect our budget.; and

WHEREAS, TITLE V STANDING RESOLUTIONS MAY 2015 PER CAPITA states; It was proposed and approved by majority vote to increase per-capita by \$1.00 in the year 2016 for a total per-capita of \$6.00 THEN, an additional \$0.50 beginning in the year 2017 for a total per-capita at that time of \$6.50 (Utah portion \$4.00 and General Grand Council portion \$2.50).; and

WHEREAS, The Utah portion has not been sufficient to cover the expenses of the Grand Council. Causing the Grand Council to pull or seek funds from other accounts.; and

WHEREAS, No organization can survive running an annual deficit;

BE IT THEREFORE RESOLVED that a MAY 2021 STANDING RESOLUTION be added to TITLE V STANDING RESOLUTIONS: The annual per-capita be raised as follows:

The Utah portion raised by \$3.00 to \$7.00 plus + General Grand Council per-capita fees (currently \$2.50) for a total per-capita of \$9.50.

## **REPORTS OF OFFICERS**

### **REPORT OF THE GRAND COMMANDER**

#### **Visitations**

My intention was to visit all Utah Commandries in person however due to the Covid-19 pandemic this was not possible. However, I did visit each of the six Utah subordinate Commandries virtually via Zoom. In addition, I attended part of the Texas Grand Commandry Sessions.

Each of the Utah visitations were done jointly with the Most Excellent Grand High Priest of the Grand Chapter of Royal Arch Masons, Jeffrey E Hamilton, and the Grand Illustrious Master of the Grand Council of Cryptic Masons Reed B Fanning. At each visitation, an educational was arranged by Companion Reed B Fanning and he is to be commended for his efforts.

At each of these visitations I discussed membership goals and things we can do to increase our membership. I also encouraged members to support our Commandry charities the Holy Land Pilgrimage and the Knight Templar Eye Foundation. Supporting our charities is a big part of who we are as Knights Templar.

#### **State of Knight Templar Commandries in Utah**

At each of the visitations I found that each Commandry was stable given the circumstances and many had candidates waiting for the time when we could resume degrees and orders. Even so membership is still a concern and efforts need to be continuously made to increase our numbers of qualified candidates. A copy of the membership plan will be included in the proceedings. Copies of the membership plan were also emailed to each Commandry. It was stated that the Grand Commandry is there to offer any assistance as requested.

#### **General Orders and Dispensations**

Pursuant to the Covid-19 pandemic and health concerns of our members General Order No. 1 was issued. This was to allow all Constituent Commandries to hold elections via Zoom or to hold elected officers in place for another year as approved by local Commandries.

A dispensation was granted for Golgotha Commandry No.7 for a requested uniform regulation change.

A dispensation was granted for El Monte Commandry to change the date of their elections to November via Zoom due to the Pandemic.

A decision to hold Grand York Rite bodies Annual Grand Sessions via Zoom on May 8<sup>th</sup> 2021 was approved by all three Grand York Rite heads. This is

due to the concern for the safety of our members during the Covid-19 pandemic.

### **Christmas and Easter Observances**

Each subordinate Commandry was encouraged to perform their own Christmas Observances. Assistance was offered if requested.

Each subordinate Commandry was encouraged to perform their own Easter Observance. Assistance was available if requested. An alternative was offered to join the Grand Encampment Easter Observance on- line.

### **Planning**

Planning has begun for the 2022 in-person Grand Sessions for next May. A York Rite Festival is being planned for this September to complete the degrees and orders for the candidates who have waiting for in-person meetings to resume. Local bodies are still encouraged to do their own work as much as possible.

Knight Templar Membership Plan for Utah:

1. Membership goal for the next 12 months is 15 new Knights.
2. We have not been able to meet this year in person, but we do have candidates waiting for degrees and orders. Some have had part of their degrees but due to the pandemic we have not been able to meet to finish their degrees and orders.
3. Utah has for the last few years have been encouraging local bodies to do their own work or combine with another nearby body to work together. This is a good idea for the candidates to have their degrees performed by the local bodies to which they will belong. This will give them a better sense of belonging and we encourage local bodies to continue with this process.
4. The problem is that sometimes we end up with candidates who have not been able to receive all their degrees and orders. To remedy this problem the Grand Heads of the three York Rite bodies will have a statewide festival each year to make sure these candidates receive all the degrees and orders they have not received. We do plan to have a statewide festival in September or when we are able to meet again safely.

5. A notice was sent to each subordinate commandry stating that even though we are not able to meet in person at the present time we need to continue to support the masonic organizations we belong to. We also need to support our masonic charities such as the Knight Templar Eye Foundation and the Holy Land Pilgrimage. These charities are a big part of who we are.
6. Included in this notice also was a direction for each subordinate Commandry to set up a membership committee. The outline was based on the Grand Master's directions:

Knight Templar Membership is our highest priority especially in this trying time:

" Every Grand, Subordinate and Constituent Commandery must have a membership committee that is active and held accountable for results. "What gets measured gets done."

" Must focus on the three R's - Recruitment, Retention and Restoration. Some commanderies focus all of their efforts on recruitment and neglect retention and restoration.

" Make conclaves interesting and educational.

" Communicate with members. Never issue a demit or suspension without PERSONAL contact.

" If we do lose someone, conduct an EXIT INTERVIEW.

#### VISION STATEMENT

It is our intent that by the end of this 68th Triennium (2021), the Grand Encampment of Knight Templars strive to achieve an increase of at least 5% in new "knightings" that year (Recruitment), suffered no more than a 2% loss in total membership from the number of demits and suspensions (Retention) and realized at least a 2% gain in the number of Sir Knights restored from suspension or demit (Restoration). Note: percentages are calculated as a % of the total membership as of the beginning of that year.

The three Rs of any campaign are recruitment, recognition, and retention. They are the foundation upon which any campaign must be built.

**RECRUITMENT:** The lifeline of any organization is built upon new members. Without a new base of membership, we cannot reach the

heights that our valiant and magnanimous Order so richly deserves. We are all Blue Lodge Masons so let us help our Blue Lodges with recruitment then recruit for York Rite from our Blue Lodges.

RETENTION: Often, the only thing a wavering brother needs is encouragement. Be a true friend to your fellow Sir Knights. Let them know we appreciate them and value them. We can turn the tide of NPDs with a friendly call or visit, informing the member of the importance of his remaining with the York Rite. A phone tree can do wonders in keeping members informed and teaching them that our Order is still relevant and has value for them.

RESTORATION (or Reactivation) is involved with reaching out to those fraters who we have lost. Find out why they left and what we can do while encouraging them to rejoin Templary Masonry. And let's add a fourth "R" and call it "Masonic and Public Relations", how we should conduct ourselves to present a better picture to all who look upon our proud Order.

The Eminent Commander, Generalissimo, Captain General and Recorder are on the membership committed for your Commandry. How you function and who does what is up to you.

We are here to serve you and if we can do anything to help you, please let us know.

Thanks to each of you for your time and your service to Templary.

More suggestions for each local Commandry are to establish a phone tree to call members, send a first contact letter to a newly raised mason and appoint ambassadors to Blue Lodges. We want to work with Blue Lodge membership so Blue Lodges and York Rite both benefit. We want to make it simple but effective.

**Utah Membership Plan for Knights Templar and York Rite in general.**

1. Knight Templar membership at the current time 276. Membership goal for next year 287.

2. Utah has for the last few years have been encouraging local bodies to do their own work or combine with another nearby body to work together. This is a good idea for the candidates to have their degrees performed by the local bodies to which they will belong. This will give them a better sense of belonging and we encourage local bodies to continue with this process.

3. The problem is that sometimes we end up with candidates who have not been able to receive all their degrees and orders. To remedy this problem the Grand Heads of the three York Rite bodies will have a statewide festival each year to make sure these candidates receive all the degrees and orders they have not yet received. We do plan to have a statewide festival in September 2021.

4. We need to continue to support all the masonic organizations we belong to. We also need to support all our masonic charities such as the Knight Templar Eye Foundation and the Holy Land Pilgrimage. These charities are a big part of who we are.

5. Each subordinate Commandry is to set up a membership committee. Membership is our highest priority, especially in this trying time. The Eminent Commander, Generalissimo, Captain General and Recorder are on the membership committee for your Commandry. How you function and who does what is up to you.

6. The three Rs of a membership plan are recruitment, recognition, retention, and restoration. They are the foundation upon which any campaign must be built. Make conclaves interesting and educational. Communicate with members and keep them informed of meetings and activities.

**RECRUITMENT:** The lifeline of any organization is built upon new members. Without a new base of membership, we cannot reach the heights that our valiant and magnanimous Order so richly deserves. We are all Blue Lodge Masons so let us help our Blue Lodges with recruitment then recruit for York Rite from our Blue Lodges. Assign members to be ambassadors to the Blue Lodges they belong to help with recruitment for Blue Lodge then for York Rite.

**RECOGNITION:** Let members know they are important. If they are deserving of an award nominate them for it. If a position is open appoint them to it and provide any assistance they may need.

RETENTION: Often, the only thing a wavering brother needs is encouragement. Be a true friend to your fellow Sir Knights. Let them know we appreciate them and value them. We can turn the tide of NPDs with a friendly call or visit. Establish a phone tree by dividing the list of members and assign officers to call members on their list. Have the officers check on how they are doing and informing the member that he is an important member. Inform them of meetings and activities and ask for suggestions on how to make his membership better for him. Never issue a demit or suspension without PERSONAL contact asking if there is anything we can do to keep him as a member.

7. RESTORATION is involved with reaching out to those fraters who we have already lost. Find out why they left and what we can do to make membership more rewarding while encouraging them to rejoin Templary Masonry.

### **FIRST CONTACT TO THE NEWLY RAISED MASON**

Dear Brother \_\_\_\_\_,

I congratulate you upon being raised to the sublime degree of a Master Mason! Masonry is full of rich teachings and enigmatic symbolism; it is nearly impossible to receive and understand it all. I encourage you to attend Lodge and witness every degree as often as you can. Every time you attend, you will pick up something "new", which may have escaped your notice from the time before. The teachings and knowledge from Masonic symbolism we call "Light" or "Divine Truth". A wise man will always have a desire for the "Light" as you did when you became an Entered Apprentice, then "more Light" as a Fellowcraft, and the "further Light" as a Master Mason.

In the Blue Lodge, its ancient secrets and basic moral principles are only partly revealed. Even when the Master Mason degree is concluded, you are left with only a Substitute Word, but you must plan for the solution of your fraternal and spiritual problems. Remember, "Behold the Temple is not yet completed" and later the Master's Word is lost, and a substitute given "Until

future generations shall find out the right". This means that there must be "further Light". And it is my duty to inform you there is! Join the York Rite, today, and discover "further Light".

From 1717, it was almost a century before the various groups in England were consolidated and the powers and prerogatives of the Grand Lodge were acknowledged and accepted. Still, the tradition that Masonry existed "From time immemorial" persisted. Changes and innovations were vigorously resisted. After years of negotiations and the testing of innumerable degrees that clamored for Masonic approval, the Masons of England formed the United Grand Lodge of England, December 27, 1813, and definitely defined the elements of Ancient Craft Masonry in their General Laws and Regulations as "Pure ancient Masonry consists of three degrees and no more, those of Entered Apprentice, the Fellowcraft, and the Master Mason, including the Supreme Order of the Holy Royal Arch." The York system is completed in the Knights Templar.

At that time, only Past Masters of Blue Lodges were qualified to receive the Royal Arch Degree. It was then deemed that this degree was so important, Master Masons, who having received the Mark Master Degree, were then able to become (Honorary) Past Masters, thus making them eligible to witness completion and dedication of King Solomon's Temple, and receive the long "lost Master's Word" in the Royal Arch Degree. In Virginia, Royal Arch Chapters confer the Mark Master Degree, Past Master Degree, Council Degrees (Select Master and Royal Master Degrees), Most Excellent Master Degree, and the Royal Arch Degree.

The Commandery of Knights Templar offers the Chivalric Orders of Christian Knighthood through the Illustrious Order of the Red Cross, Mediterranean Pass and Order of Malta, and the Order of the Temple. These Orders, as they are called, are most impressive and explain the Christian interpretation of Freemasonry. Discover for yourself, "Why every Christian Mason should be a Knight Templar."

The Virginia's York Rite provides that further "Light" through the most beautiful Degrees and Orders in all of Freemasonry given by Royal Arch Chapters, and Commanderies of Knights Templar.

No doubt you have been told, or you will be told eventually, that the degrees conferred in the Blue Lodge embodies the whole of "Light". That is true, but it is also misleading! The old idiom "the devil is in the details" meaning that something might seem simple at a first look but will take more time and effort to compete than expected.

Many Masonic scholars agree that the narrative of the Craft, as illustrated in the three degrees, is not the whole story. The Degrees of York Rite Masonry complete the story and provide answers to many questions that the newly raised Master Mason may have. The symbolism of the Royal Arch picks up where the Symbolic (Blue) Lodge leaves off. The symbolism of the Blue Lodge degrees emphasizes the building of King Solomon's; the Royal Arch Masonry continues in this vein by emphasizing symbols and allegories of the Second Temple, the Ark of the Covenant, a further symbolism of Solomon's temple completed, and the Lost Word which is given to the Royal Arch Mason. The Commandery Knights Templar Orders have a Christian orientation, their teachings are based on the crusades of the original Knights Templar and are based upon the practice of the Christian virtues, moral values, and spiritual lessons.

Freemasonry teaches us that it is a progressive science, a system of ethics wherein moral precepts is taught by lessons based on the allegorical use of the operative craftsman's tools. Symbolic (Blue Lodge) Freemasonry prepares the candidate in the use of symbolic stone for that Spiritual Temple. Capitular and Cryptic (Royal Arch Chapter) Freemasonry instructs the candidate in the allegorical use of operative tools of the craftsman. Finally, Chivalric (Commandery Knights Templar) Freemasonry instructs in the allegorical use of the weapons in the discharge of the duties of knighthood whereby the Moral Temple, built and restored in Symbolic, Capitular and Cryptic Freemasonry, can be defended and beatified by the precepts of Christianity.

The rich history of York Rite Masonry is undeniable. The York Rite is historically the oldest and purest of the appendant Rites. Every Master Mason should be fascinated by the lessons and mysteries of Freemasonry provided by the Blue Lodge

As a Master Mason, you are entitled to petition the Appendant Bodies of Freemasonry. I look forward to hearing from you soon and again welcome you as a Brother to our Fraternity.

**Proposal #1**

**Proposed Amendment to the Constitution of the Grand Commandery  
of Utah, Knights Templar.**

WHEREAS, **Section 2-8 (A) Standing Committees** states; Before each Annual Conclave adjourns, or within thirty-days thereafter, the Grand Commander elected at such Annual Conclave, **shall appoint** the following Standing Committees:

- A. Committee on Masonic Jurisprudence

- B. Committee on Finance
- C. Committee on Grievance and Appeals
- D. Committee on Education
- E. Committee on Fraternal Relations
- F. Committee on Triennial Conclave
- G. Committee on Utah York Rite Education Fund
- H. Committee on Annual York Rite Sessions

Each Committee shall consist of three or more members and the first named shall be the Chairman, and shall serve for one year or until their successors have been appointed. Any recommendations made by either Standing or Special Committees that necessitate a change of the rules, regulations, operations or finances shall be handled in the same time frame and manner as for proposals etc.. ; and

WHEREAS, **Section 2-9 (B) FINANCE** states; The finance committee shall be a Joint Standing Committee of at least four (4) in number including a chairman. With one of the four being **elected annually to a four-year term**. The election of this member shall be determined by a majority vote of the delegates present, held during the Joint portion of the Grand York Rite sessions. The initial term will be determined by elections of one each 1-year, 2-year, 3-year and 4-year members. The Grand High Priest, Grand Illustrious Master and Grand Commander will be an added part of this committee. The purpose of the committee is to manage the funds of the Grand York rite Bodies. The actions of this committee shall be determined by majority vote of the finance committee. The ballots are to be counted as one person, one vote. The Grand secretary-Recorder and Grand Treasurer will be ex-officio members for the purpose of record keeping, minutes, and information with no power to vote on actions of the finance committee. ; and

WHEREAS, **Section 2-8** and **Section 2-9** are in conflict with each other concerning how members of the **Finance Committee** are chosen. ; and

WHEREAS, **Section 2-9 (B)** is more specific in the make-up and duties of the **Finance Committee**;

BE IT THEREFORE RESOLVED that **Section 2-8 (A)** be amended as follows:

B. Finance Committee be removed and the standing committees be re-lettered A thru G.

- A. Committee on Masonic Jurisprudence
- B. Committee on Grievance and Appeals
- C. Committee on Education
- D. Committee on Fraternal Relations
- E. Committee on Triennial Conclave
- F. Committee on Utah York Rite Education Fund
- G. Committee on Annual York Rite Sessions

**Proposal #2**

**Proposed Amendment to the Constitution of the Grand Commandery of Utah, Knights Templar.**

WHEREAS, **Section 2-9 (B) FINANCE** states; The finance committee shall be a Joint Standing Committee of at least four (4) in number including a chairman. With one of the four being elected annually to a four-year term. **The election of this member shall be determined by a majority vote of the delegates present, held during the Joint portion of the Grand York Rite sessions.** The initial term will be determined by elections of one each 1-year, 2-year, 3-year and 4-year members. The Grand High Priest, Grand Illustrious Master and Grand Commander will

be an added part of this committee. The purpose of the committee is to manage the funds of the Grand York rite Bodies. The actions of this committee shall be determined by majority vote of the finance committee. The ballots are to be counted as one person, one vote. The Grand secretary-Recorder and Grand Treasurer will be ex-officio members for the purpose of record keeping, minutes, and information with no power to vote on actions of the finance committee.

They may by majority vote appoint a duly qualified outside financial advisor or financial institution for suggestions and advice. The finance committee shall hold and take title to all of the assets and funds of the Grand Chapter, Grand Council and Grand Commandery, with the exception of those funds held by the York Rite of Utah Foundation. They may co-mingle them, as long as they are spread on the books individually, as part of the Grand York Rite Funds except the general operating funds. They may loan and invest funds in such manner as the Grand Chapter, and/or Grand Council, and/or Grand Commandery may request from time to time, or in the absence of such specific direction, to the best of their judgement and ability in securities generally accepted by the Trust department of sound financial institutions. This may include but not limited to United States Government Bonds, Treasury Bills, or other certificate of indebtedness, State and Municipal Bonds, Savings Accounts and Certificates and Corporate Bonds and Mutual Funds. A portion of these investments should be available in a timely manner transferable to pay the indebtedness of the Grand Chapter, Grand Council and Grand Commandery.

All actions taken by the Finance Committee shall be governed by the prudent man rule and with agreement of the majority. In case of a deadlock the duty shall fall to the Chairman for decisions.

They shall reinvest the interest and dividends or deposit to the General Fund amounts needed as circumstances warrant. They shall make a complete and detailed report of all assets and funds in their possession at

each Annual Sessions and shall annually audit the books of the Grand Recorder and Grand Treasurer, and shall certify their findings at the Joint Portion of the Annual Grand York Rite Sessions.

They will also prepare and submit a budget for the ensuing year for each Grand York Rite body for action at the annual sessions.

Any item or items not covered herein shall be governed by the requirements of the Code and Trial Code of the Grand Lodge F. & A.M. of Utah and Masonic usage. ; and

WHEREAS, there is no roll call taken or credentials report given. ; and

WHEREAS, there is no way of knowing who the eligible delegates to vote are without a credentials report and roll call.

BE IT THEREFORE RESOLVED that **Section 2-9 (B) Finance** be amended as follows:

First paragraph; The Finance Committee shall be a Joint Standing Committee of at least four (4) in number including a chairman. With one of the four being elected annually to a four-year term. The election of this member shall be determined by a majority vote of the delegates present, **held in the first body to open per Section 2-3 Conclaves (B) where a credentials report and roll call is taken to establish the eligible delegates.** The initial term will be determined by elections of one each 1-year, 2-year, 3-year and 4-year members. The Grand High Priest, Grand Illustrious Master and Grand Commander will be an added part of this committee. The purpose of the Committee is to manage the funds of the Grand York Rite Bodies. The actions of this committee shall be determined by majority vote of the finance committee. The ballots are to be counted as one person, one vote. The Grand Secretary-Recorder and Grand Treasurer will be ex-officio members for the purpose of record keeping, minutes, and information with no power to vote on actions of the finance committee.

**Proposal #3**

**Proposed Amendment to the Constitution of the Grand Commandery Knights Templar of Utah**

WHEREAS, Section 1-7 ASSESSMENTS states; It shall possess authority to require from the several Commandries within its jurisdiction, such proportion of the sums received by them for conferring the Orders, and also sums in the form of annual dues from the respective members, as may be necessary for the support of the Grand Commandery.; and

WHEREAS, Section 2-19 FINANCES states; The revenue of the Grand Commandery shall be derived from fees and dues charged as follows;

(A) For a Dispensation to form a New Commandery, One Hundred dollars (\$100.00).

(B) For each Order of the Temple conferred, Two Dollars (\$2.00) to be paid by the Commandery of which the candidate receiving the Order shall thereupon become a member, provided that no fee shall be due the Grand Commandery for courtesy work done for Commanderies outside of Utah.

(C) Each Constituent Commandery shall remit to the Grand Commandery, at the time of making the Annual Returns, the assessed dues for each Sir Knight who was a member at the close of the fiscal year. For current amount, refer to the last date on this subject in TITLE V Standing Resolutions.

(D) For the Knight Templar Eye Foundation, One Dollar (\$1.00) per member, or refer to 18 2 (a) (b) (c).

(E) For the Triennial, Thirty-five cents (\$.35) per member.

(F) Such special assessments and fees as the Grand Commandery shall levy.; and

WHEREAS, The Grand Encampment Triennial Conclave is held after our annual Conclave.; and

WHEREAS, should a per capita increase or decrease be approved at the Triennial. Such increase or decrease becomes affective before our next Conclave. ; and

WHEREAS, This increase or decrease would affect our budget. ; and

WHEREAS, TITLE V STANDING RESOLUTIONS MAY 2007 PER CAPITA states; It was proposed by the Finance Committee at the Joint Sessions and approved by majority vote to increase per-capita by \$5.00 in the Grand Commandery. Section 2-19(c) will read: For each Knight Templar reported a member on the Annual Returns of a Constituent Commandery (\$15.00) Fifteen Dollars. (Utah portion \$6.00 and Grand Encampment portion \$9.00). ; and

WHEREAS, The Utah portion has not been sufficient to cover the expenses of the Grand Commandery. Causing the Grand Commandery to pull or seek funds from other accounts. ;and

WHEREAS, No organization can survive running an annual deficit; BE IT THEREFORE RESOLVED that a MAY 2021 STANDING RESOLUTION be added to TITLE V STANDING RESOLUTIONS: The annual per-capita be raised as follows:

The Utah portion raised by \$1.00 to \$7.00 plus + Grand Encampment per-capita fees (currently \$9.00) for a total per-capita of \$16.00.

**Proposal #4**

**Proposed Change to the Constitution of the Grand Commandery of Utah, KT**

Whereas Section 1-12 Amendments specifies the procedure to make changes to the Constitution of the Grand Commandery of Utah, and Section 2-25 Amendments also specifies the procedure to make changes, however in a more detailed matter. Let it be resolved to amend Section 1-12 to be written as Section 2-25, and delete Section 2-25 from the Constitution.

Currently, Section 1-12 reads as follows:

Section 1-12 AMENDMENTS

The Grand Commandery, upon the concurrence of two-thirds of its members present and voting at any Annual or Special Conclave, may revise, amend and alter this Constitution, provided, however, that a written copy of the motion so to amend or alter shall be filed with the Grand Recorder of the Grand Commandery at least forty-five (45) days before the day on which the Conclave is to be held at which such motion is to be considered, and copy thereof shall be inserted in the Notice of the Conclave and presented by the Grand Recorder to the Grand Commandery for consideration.

And Section 2-25 reads as follows:

Section 2-25 AMENDMENTS

AMENDED August 2020

All proposed amendments to the Laws relating to Grand Commandery shall be submitted in writing to the Grand Recorder at least forty-five days before the next annual communication. At least THIRTY-FIVE days before such annual conclave of Grand Commandery the Grand Recorder shall transmit to the Recorders of the several constituent Commanderies of this jurisdiction, and to the members of the Jurisprudence Committee of Grand Commandery, copies of any such proposed amendments.

All proposed amendments shall first be referred to the Committee on Jurisprudence for its opinion and report. Any proposed amendment, ruled by the Committee on Jurisprudence to be "not" in proper form, shall not be placed upon the floor of the annual conclave of the Grand Commandery, for vote, until said amendment shall have been put in proper form. Responsibility for "Proper Form" shall be with the author of the amendment. The Committee on Jurisprudence shall advise the author, or authors, of

proposed amendments, prior to the annual conclave, if such amendments are "not in proper form". *After "proper form" is satisfied*, if the amendment is then approved in annual convocation by a majority of the votes, then such amendment shall become effective. Grand Commandery may suspend the forgoing provisions by two-thirds vote at the Annual Conclave or a Special Conclave called for such Purpose.

With approval of the voting delegates, the change would be reflected as follows:

#### Section 1-12 Amendments

All proposed amendments to the Laws relating to Grand Commandery shall be submitted in writing to the Grand Recorder at least forty-five days before the next annual communication. At least THIRTY-FIVE days before such annual conclave of Grand Commandery the Grand Recorder shall transmit to the Recorders of the several constituent Commanderies of this jurisdiction, and to the members of the Jurisprudence Committee of Grand Commandery, copies of any such proposed amendments.

All proposed amendments shall first be referred to the Committee on Jurisprudence for its opinion and report. Any proposed amendment, ruled by the Committee on Jurisprudence to be "not" in proper form, shall not be placed upon the floor of the annual conclave of the Grand Commandery, for vote, until said amendment shall have been put in proper form. Responsibility for "Proper Form" shall be with the author of the amendment. The Committee on Jurisprudence shall advise the author, or authors, of proposed amendments, prior to the annual conclave, if such amendments are "not in proper form". *After "proper form" is satisfied*, if the amendment is then approved in annual convocation by a majority of the votes, then such amendment shall become effective. Grand Commandery may suspend the forgoing provisions by two-thirds vote at the Annual Conclave or a Special Conclave called for such Purpose.
