MINUTES

Annual Joint Session

Embassy Suites Hotel, Salt Lake City, Utah

May 9, 2014

The joint session was opened in form by Malta Commandery #3. Grand Commander, Preston “Marty” Martineau, welcomed all. The presiding officers of Utah Masonic Organizations were introduced and welcomed.

A motion was made and approved to accept the pre-printed reports pertinent to the Joint Sessions which are in the packet. Reports provided in the packet are: Minutes of 2013 Sessions, Unfinished business, Returns of Constituent Bodies, Time and Place, Festival Committee, Audit, Treasurer’s, York Rite Trust, Consolidated Budget, Southwest Regional Conference, Appeals and Grievances, Public Relations, York Rite College. The Credentials Committee provided a preliminary report that there are 38 members in attendance.

As a part of the York Rite Trust report it was noted that there is a vacancy in the Trustees. Frank C. Baker was nominated and elected to serve as Trustee to the York Rite Trust.

Drew C. Sanders, Grand Master of Utah, Free and Accepted Masons was introduced and presented words of appreciation and thanks to the York Rite of Utah.

Overview was given of the issues with the Logan Chapter. There has been a challenge with this chapter for several years. They have a lot of traffic through the chapter due to college students who join, then move on. Membership is currently approximately 20. This year the Sec/Recorder was tasked to get people to work through the issues facing the Chapter, determine who belonged to the group, and who had paraphernalia. Only 2 people have been listed as officers for several years. They have been given the challenge of getting participation. This year they proposed an initiative to enliven the group as a representative of Northern Utah. Representatives from Corrine Blue Lodge were enthusiastic with this plan. A proposed bylaws certification was mailed to all members of record. Many of those

mailed items were returned. The proposed name change of Bear River Chapter #8 did not pass (due to cost involved with setting up under a new name). The proposed change to monthly meetings did not pass. All other proposals passed. Many members affiliated with Logan to help them move forward. This is considered a success story of getting this group revitalized.

Ongoing discussions are indicating that interest of Corrinne, and other northern groups, is due to the Mark Master Lodge and that the Mark Master program has helped bring about a whole reckoning in York Rite.

Joint Session was closed by Grand Commander Preston “Marty” Martineau.

AUDITING COMMITTEE

To members of Grand York Rite of Utah:

I have audited the accompanying consolidated financial statements of Grand York Rite of Utah which comprise the consolidated statement of financial position as of March 31, 2014 and the related consolidated statements of activities, and cash flows for the year then ended, and the related notes to the financial statements.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditors' Responsibility

My responsibility is to express an opinion on these financial statements based on my audit. I conducted my audit in accordance with auditing standards generally accepted in the United States of America. Those standards require that I plan and perform the audit to obtain reasonable assurance about whether the consolidated financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the consolidated financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. Accordingly, I express no such opinion. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluating the overall presentation of the consolidated financial statements.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my audit opinion.

In my opinion, the financial statements referred to above present fairly, in all material respects, the financial position of Grand York Rite of Utah as of March 31, 2014, and the results of its operations and its cash flows for the year then ended in conformity with accounting principles generally accepted in the United States of America.

GRAND YORK RITE OF UTAH Notes to Financial Statements March 31, 2014

NOTE 1 - ORGANIZATION

Grand York Rite of Utah, (the Rite) was incorporated as a not-for-profit organization as a domestic fraternal society and association under IRS code 501(c)(10). The Rite consists of three bodies;

Royal Arch Masons of Utah Most Excellent Grand Chapter, Royal and Select Masters of Utah Grand Council, and Grand Commandery of Knights Templar of Utah.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

a. Basis of Accounting

The financial statements of the Rite are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

The Rite has adopted the provisions of Accounting Standards Codification 958, *Not-For-Profit Entities* (ASC 958), and Accounting Standards Codification 720-25, *Contributions Made* (ASC 720-25). Under these ASC's, the Rite is required to report and record its financial position, activities and contributions received under three classes; permanently restricted, temporarily restricted and unrestricted. These classes are determined by the donor's restrictions for the use of the funds or the lack thereof. When a donor's restriction expires, temporarily restricted net assets are reclassified as unrestricted net assets and are shown in the statement of activities as net assets released from restriction. Temporary restrictions expire when a time restriction is met, or the purpose of the restricted funds has been accomplished. As of March 31, 2014, the Rite had temporarily restricted and permanently restricted net assets totaling \$110,386 and \$173,177, respectively.

b. Cash and Cash Equivalents

The Rite considers all highly liquid debt instruments with an original maturity of three months or less to be cash equivalents.

c. Investments

The Rite accounts for investments in accordance with ASC 958-320, *Investments – Debt and Equity Securities*. Under ASC 958-320, investments in marketable securities with readily determinable fair values and all investments in debt securities are

recorded at their fair value in the statement of financial position. Unrealized gains and losses are included in the change in net assets.

Donated investments are reflected as contributions at their market values at the date of receipt. Dividend and interest income and gains and losses on investments are reflected in current unrestricted activities unless temporarily or permanently restricted, either by law or explicit donor stipulation, in which case they would be reported in either temporarily or permanently restricted activities.

d. Concentration of Credit Risk

The Rite maintains its cash in bank deposit accounts which, at times, may exceed federally insured limits. Accounts are guaranteed by the Federal Deposit Insurance Corporation (FDIC) up to certain limits. At March 31, 2014, the Rite did not have funds in banks in excess of the FDIC insured limits. The Rite has not experienced any losses in such accounts.

e. Income Taxes

The Rite is a non-profit corporation operating under a lodge structure and is not subject to federal income taxes under Section 501(c)(10) of the Internal Revenue Code. The Rite files a Form 990 tax return.

As of March 31, 2014 and for the year then ended, the Rite has not engaged in any activity which management considers to be activity that could result in a loss of their 501(c)(10) designation. In addition, management does not consider any of the activity of the Rite to be considered unrelated business income that could result in income tax. For the year ended March 31, 2014, there was no tax interest or penalties reflected in the statement of activities or in the statement of financial position. The Rite is no longer subject to U.S. federal, state, and local income tax examinations by taxing authorities for years before 9.

f. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses. Actual results could differ from those estimates. Management bases its estimates on historical experience and on various other assumptions that are believed to be reasonable under the circumstances in making judgments about the carrying value of assets and liabilities that are not readily apparent from other sources. While actual results could differ from those estimates, management believes that the estimates are reasonable.

n. Fair Value of Financial Instruments

The Rite's financial instruments include cash and cash equivalents, marketable securities and mutual funds, and accounts payable. The carrying amounts of these assets and liabilities approximate fair values because of the short-term nature of these instruments.

NOTE 3 - TEMPORARILY RESTRICTED NET ASSETS

Temporarily restricted net assets consist of contributions to the Rite which were placed in a trust and are only released from restriction by designation of the trustee. Total temporarily restricted net assets totaled \$110,386 as of March 31, 2014.

NOTE 4 - FAIR VALUE MEASUREMENTS

The Rite determines fair value based on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value hierarchy prioritizes observable and unobservable inputs used to measure fair value into three broad levels. These levels, in order of highest priority to lowest priority, are described as follows:

Level 1 – Quoted prices (unadjusted) in active markets that are accessible at the measurement date for assets or liabilities.

Level 2 – Observable prices that are based on inputs not quoted on active markets, but corroborated by market data.

Level 3 – Unobservable inputs are used when little or no market data is available. The following table summarizes the assets of the Rite subject to these valuation approaches.

GRAND YORK RITE TRUST REPORT

Herewith is the report of the Board of Trustees of the Grand York Rite of Utah Trust for the period of 10 May, 2013 through 10 May, 2014.

The value of the trust portfolio and cash account as of 30 April, 2014, stood at \$280,849.02 which is a fourteen and one-half (14.5) percent increase since 30 April, 2013. The portfolio is a managed account and consists of moderate risk investments in accordance with our financial management policy. We did change firms during the year from UBS Wealth Management to Wells Fargo Financial advisors. However, we retained the same advisory group maintaining Darrell Jones as the chief advisor.

Annual earnings from the account are distributed to the Grand York Rite Bodies in accordance with the Trust By-laws and are used for the benefit of all the constituent Bodies. The voting members of the Board consist of the presiding officers of each Grand Body and four elected Trustees. Meetings are held periodically at which time the presiding Grand officers make request, each of which is voted on by the voting members and disbursement of funds is made based on funds available and type of request. \$4650.00 was authorized at the Board meeting 8 June, 2013. However, this past year only \$1458.87 was actually disbursed; \$2100.00 was authorized for the Spring Festival and the Grand Commander's Ball and \$500 was authorized for the Grand York Rite Conference. However, funds for both these activities were never requested.

The next Board meeting is scheduled for 10:00 A.M., 7 June, 2014 at Salt Lake City Masonic Temple. We ask all Board members to be in attendance and the three Grand presiding officers make their funding requests. We estimate at this time there will be approximately \$3500.00 available. Please put on your thinking caps and come up with some unique and creative ideas for projects that will be of general benefit to the York Rite statewide. The Grand Recorder will verify the above date and send advance notification to all Board members.

Each elected Board member serves a four year term. This year ends Brother Bill Baker's fourth year. He is retiring and does not seek re-election We wish to thank him for the many years of service he has devoted to Trust Board. His presence will be sorely missed.

Again, we thank the York Rite Bodies for the opportunity to serve the Utah York Rite. We will continue to administer the Trust to the best of our abilities.
