GRAND TREASURER REPORT

Overall:

Overall the financial health of the Grand York Rite of Utah is healthy. The body is able to keep operating expenses within operating income and has therefore not had to draw from investment accounts in order to cover operating expenses. The investment

accounts are being managed by Baird and appear to have a reasonable asset allocation and have had the opportunity to grow in the current year.

Statement of Financial Position (Balance Sheet):

Please refer to the following Statement of Financial Position.

The Statement of Financial Position shows the assets and liabilities of the Grand York Rite of Utah as of year-end as well as a comparison to the year-end balance of the previous year. The assets include a Baird investment account, a MACU Checking and Savings account, and a Paypal account. There is a net increase of \$7,413.34 in assets, mostly based on an increase in the investment account balance. The investment account asset allocation is 63.22% Equities, 36.35% Fixed Income, and 0.42% Cash. The liabilities include funds received for Fiscal Year 2025 income that was received in Fiscal Year 2024 and is therefore deferred until the following year when the income will be recognized. During May 2024 we received FY25 Per Capita of \$1,018 and FY25 Sessions Income of \$2,569.50.

Taxes:

There are 3 entities (23-7177133 ROYAL ARCH MASONS OF UTAH MOST EXCELLENT GRAND CHAPTER, 23-7618802 KNIGHTS TEMPLAR OF THE UNITED STATES OF AMERICA, 87-6124160 ROYAL AND SELECT MASTERS OF UTAH GRAND COUNCIL) those 3 entities file an independent 990 (technically 990-Ns because they are below the income thresholds). RAM's fiscal year is 3/31; KT's fiscal year is 6/30; and R&S is 4/30. The 990s for their fiscal year ended in 2023 have all been filed. Those 3 entities are not registered with the state of Utah as not-for-profit entities (note that there is an entity matching the KT name if you do a business search, however, that is

Utah #1's which was set up so that Utah #1 could open a bank account with America First and now that registration is expired).

In 2020 another entity was organized, 85-1736317 GRAND YORK RITE OF UTAH. Per David Reed, this entity was set up as required by Baird, which only required an entity to be registered with Utah to open the account. Baird did not require them to file for a tax-exempt status and this was not completed. I filed the form 1023 on February 16, 2024, to apply for a tax-exempt status. As of April 17, 2024, the IRS has processed requests submitted on and before July 20, 2023, so I don't anticipate a response until the end of the year. Once that is approved then that entity will be required to file 990-Ns each year.

Personal:

As I will be attending military training at Redstone Arsenal during the Annual Sessions and not there physically to give this report I wanted to add a personal comment to the end of this report. It has been an honor to serve the Grand York Rite of Utah as the Grand Treasurer this past year. I am happy to continue to serve at the pleasure of the body, and if elected, will continue to serve. I've been informed that there is another Sir Knight interested in serving as Grand Treasurer and if it is the will of the body that someone else be Grand Treasurer I have no problem with that. I will continue to help ensure that tax-exempt status is received for the entity formed in 2020 (mentioned above) and am happy to assist with the review and preparation of financials if that is needed.

JURISPRUDENCE COMMITTEE REPORT

MEMBERSHIP

The Grand York Rite of Utah this year was able to Exalt and Greet 14 new Companions and Knighted 13 Sir Knights. We did, however, experience a net loss of membership in 2023. 7 companions in the Chapter, 5 companions in the Council and 7 Sir Knights in the Commandery. The largest reason for membership loss was suspension.

Your Committee on Membership wishes to recognize and report the following. Continuing efforts to promote and invigorate the York Rite Bodies in Utah have been made through the several constituent York Rite Bodies within this Grand Jurisdiction. This committee actively studies the trends in fraternal membership and the challenges we, as a fraternal order, face currently. The matter of membership should be properly denominated in a fluid, four-pronged approach:

Attraction:

This committee recommends that all York Rite Masons regularly attend Blue Lodge and be a shining example of what the York Rite is about. Attend Lodge in your uniform, provide an educational about the intriguing aspects of the York Rite and why they should join, have the Keystone Mark Master Lodge come and perform the Mark Master degree for the Master Masons in your lodge are just a few examples of things we can do as York Rite masons to attract new members to our Rite.

Attainment:

Invite brothers out to events being hosted by your York Rite body so they can get to know the members. If you are not holding any public events such as meetups and breakfasts/dinners etc. we would recommend you start doing something. Ensure that you are personally inviting your lodges to installations as well as Easter and Christmas Observances. Some York Rite bodies have had great success in coupling these with other Blue Lodge events such as installations etc.

Retention:

Retention is a matter of fulfilling the needs of the Members present on our rolls/ roster and added value to their experience. Below are some reasons why members may not attend and actions we can take to retain membership.

- Personality Conflict Members and officers should be educated in conflict resolution. An offending member must be counseled, and his negative behavior, actions, speech, and attitude must be corrected. Peace and Harmony should prevail in every group or body of Freemasonry.
- 2. Connection We must remind each other of the reason we are called companions. When we act in sincerity and treat each other like Brothers, Companions, and Sir Knights then we create a supportive environment of mutual respect, Brotherly Love, and Affection. We must show in our actions that every member adds value to the Masonic experience. Reach out to companions that have not attended a couple meetings to check up on them.
- 3. Communication Platforms such as Constant Contact, Google Calendar, Signal App, X (formerly Twitter), Facebook, and quality Websites should be employed and constantly maintained and updated. All efforts of communication including a personal phone call are necessary to create open and clear communication between the membership.
- 4. Education Of course, it must be said, that our greatest resource for education and esotericism is our ritual. Ritual programs should be developed to encourage the study and contemplation of our ritual. Educational topics that provoke thought and discussion should be presented at every event possible.

Restoration:

Masons exit the south gate for many reasons, some of which are well within our ability to solve. Our biggest loss of membership this year was due to Suspension. Over the past several years leaders within the fraternity have addressed this matter in meaningful ways. Each York Rite body should be encouraged to do whatever it can to help a companion restore their membership and return to the Rite.

Recommendations:

It is a requirement that every York Rite body have a membership committee however, it should be the focus of every member to participate in membership. It should be the sole purpose of the membership committee to approach membership from this Four-pronged approach.

Do not let something like money come between your York Rite body and restoring a brother who may be in arrears. Each York Rite body is admonished to work with and come up with a solution that works best for them and their members.

Each York Rite body is encouraged to perform their own ritual or at the very least participate in a Mini festival.

"Miniature" York Rite Festivals continue to be held at least twice a year and hold them around the state to encourage members from all around the jurisdiction to participate.

Mentors and Lodge Ambassador programs should be further developed within the several York Rite Bodies of this Grand Jurisdiction.

Robust Educational programs should be created at each York Rite body.

Create legislation to codify the membership committee into our bylaws.

GRAND YORK RITE TRUST REPORT

Companions and Sir Knights,

Herewith is the report of the Board of Trustees of the Grand York Rite of Utah Trust for the period since the last Grand York Rite Sessions 2023.

Beginning value of 2023, we were at \$373,627.

We ended the year at \$412,678.

We increased by \$39,051 and continue YTD another \$19,552 to

As of May 09, 2024 we are at \$432,230.

We started October of 2016 with Baird with only \$271,093. We are still up. \$161,137 roughly 6 years

I again thank the expertise of Alex Wheeler of RW Baird, and the investment strategy adopted by this Board. None of us knows what is coming in these times of unprecedented inflation and irresponsible fiscal policy but I still feel better with Alex at the controls.

We have not granted any disbursements this year as none were requested. We have had administrative tallies against the trust such as supplies and the accounting firm. We remind the members the monies from this Trust are for the promotion of York Rite in Utah. This is our mandate.

Alex Wheeler of RW Baird has made changes as per our investment strategy throughout the year to deal with our fluctuating markets.

We also continue to work with Companion Benjamin Young to handle our tax returns, etc. All tax returns, etc. are currently being prepared.

We anticipate costs for the 2024-2025 year will be similar to previous requests.

We continue to be willing to help aide and assist The Grand York Rite and would please ask again that the Grand Bodies prepare their budgets accordingly before asking for disbursements from the trust.

Proposed change to the "Constitution, Laws & Regulations of the Grand Chapter Royal Arch Masons of the State of Utah"

Whereas Section 3-5 of the By-Laws for the Grand Chapter Royal Arch Masons of Utah states that a Quorum shall consist of 5 members of a constituent body to conduct business

And whereas the ritual book from the General Grand Chapter of Royal Arch Masons International that has been adopted as the official ritual for the Grand Chapter Royal Arch Masons of Utah does not contain a short form opening for the Royal Arch Degree

And whereas there exists no provision to declare a body open in the By-Laws for the Grand Chapter Royal Arch Masons of Utah

And whereas there exists no short form opening to allow for the opening of a Chapter to conduct business

Be it therefore resolved to accept the following Ritual as the official Short Form Opening to be used when there are at least 5 regular members of the constituent chapter present for the purpose of conducting business.

ROYAL ARCH RESEARCH ASSISTANCE

Throughout this Capitular year, all Chapters were encouraged to donate to the Royal Arch Research Assistance and come up with ideas to generate donations for this amazing and important Charity. Information was also sent for Chapters to use as education to help promote the RARA. Several Chapters were able to donate to the RARA this year and I commend their efforts in supporting this cause. In total, we were able to donate \$3,145. I would like to especially recognize the hard work of Companion Chris Mitchell and the companions of St. George Chapter No. 10 for raising \$1351.50 and the Companions of Keystone Mark Master Lodge No. 00 for raising \$1625 for the RARA charity this year. Great work!

The Royal Arch Research Assistance's primary focus is to better understand and mitigate the difficulties associated with Central processing disorder Central Auditory Processing Disorder (CAPD) is a hearing deficiency that does not allow those afflicted to distinguish sounds that can be heard by those with regular hearing. When a sound occurs, the sound is taken into the inner ear and delivered to the brain and the brain translates what is being heard. When a person is deaf, the part of the ear that delivers the sound to the brain does not function. When a person has central auditory processing Disorder (CAPD), the part of the brain that translates what the ear delivers does not function properly. The person with CAPD can hear sounds, but how the brain translates the sound is incorrect, and the result is a garbled message. People who have CAPD have normal hearing, so they are not considered hearing impaired. The neurological processing of the sounds they hear is impaired, which is why it's called a processing disorder. Research is developing paths of opportunity to correct this problem, and your Royal Arch Research Assistance (R.A.R.A.) contributions support these efforts.

OFFICER REPORTS

REPORT OF THE MOST ILLUSTRIOUS GRAND MASTER

For my official visitations to Midvale, Ogden and Price York Rite Cryptic Mason constituent Councils of Utah MIPGM, Jay Mitchell, was my representative. For my official visitations to Ogden and Salt Lake my representative was Right Illustrious Deputy Grand Master, Charles Warren, Sr. I personally visited St. George. At each visitation I or through my representatives, I caused to be made presentations of: Membership and suggestions. A summary consists of the three "R"s, Recruitment, Retention and Restoration.

Recruitment:

We are all Blue Lodge Masons and should assist our Blue Lodges with recruitment then recruit from them for York Rite. That way both bodies benefit, and we will have a sense of cooperation with our Blue Lodges. Let Master Masons know they will receive the lost Masters Word and continuing knowledge in Masonry.

Retention:

Make meetings short, interesting and have fun. Establish a phone tree with the officers of local York Rite Bodies. Divide the membership among officers and make phone calls to members. Do a wellness check "how are you doing and is there anything we can help with?" Inform members of meetings and activities. "We would love to see you if you can make it." If we are losing a member do an "exit interview" to let them know they are valued members. Ask why they are leaving and what we can do to keep them as members.

Restoration:

Is involved with reaching out to members we have lost. Let them know we care about them, and they are important to us. Find out why they left and what we can do to help them rejoin York Rite. You may not get everyone to rejoin but some may rejoin. Every member counts.

Charity:

At each visitation a presentation of the Cryptic Mason Medical Research Foundation was made.

Currently, the CMMRF is supporting medical research into eight critical areas through the Indiana University School of Medicine. Each of the eight research fields are medical conditions that afflict millions of people on an annual basis. Each of you will undoubtedly have multiple relatives and friends; if not yourselves, that are afflicted by these conditions.

ABDOMINAL AORTIC ANEURYSM (AAA) is an enlargement of the aorta which is the main vessel from the heart to the rest of the body. The enlargement of the aorta many times leads to rupture and death. Research is being done with stem cells to prevent enlargement and save lives.

PERIPHERAL ARTERIAL DISEASE (PAD) is a restriction in blood flow sometimes leading to amputation of the leg. Dr. Michael Murphy is now doing experimental foot ulcer treatments on humans restoring blood flow with amazing results.

HEART FAILURE occurs when the heart muscle doesn't pump blood as well as it should and can be fatal. Research is assessing the ability of stem cells to improve heart function and actually grow new heart muscle in patients with heart failure after a heart attack.

DIABETES is a chronic, metabolic disease characterized by elevated levels of blood glucose (or blood sugar), which leads over time to serious damage to the heart, blood vessels, eyes, kidneys, and nerves. Research is under way on this condition.

CANCER is the uncontrolled growth of abnormal cells in the body. Cancer develops when the body's normal control mechanism stops working. Old cells do not die and instead grow out of control, forming new, abnormal cells. These extra cells may form a mass of tissue, commonly known as a tumor. Current Research is underway in modulating the patient's immune system to fight this disease.

STROKE is defined as a loss of blood flow to part of the brain, which damages brain tissue. Strokes are caused by blood clots and broken blood vessels in the brain. Symptoms include dizziness, numbness, weakness, paralysis, on one side of the body, and problems with talking, writing, or understanding language. Research is underway to treat this condition.

ARTHRITIS is the swelling and tenderness of one or more joints. The main symptoms of arthritis are joint pain and stiffness, which typically worsen with age. The most common types of arthritis are osteoarthritis and rheumatoid arthritis. Other types are · Psoriatic Arthritis. · Gout. · Lupus. Research is underway to treat this condition.

PANCREATITIS is inflammation of the pancreas. The pancreas is a large gland behind the stomach, close to the first part of the small intestine. The pancreas has two main functions—to make insulin and to make digestive juices, or enzymes, to help you digest food. When the pancreas is inflamed, the powerful digestive enzymes it makes can damage its tissue. The inflamed pancreas can cause the release of inflammatory cells and toxins that may harm your lungs, kidneys and heart.

In conclusion, the CMMRF is one of the most important charities that we as Masons support. And it affects the greatest number of people with the health issues above. Please do what you can to support this important charity.

Awards:

A presentation for Cryptic Mason awards was made at each visitation. I do not believe in giving out awards just to give out awards. However, if a member is doing a great job in your council, then he should be rewarded. This will not only reward him but encourage him to continue his exemplary efforts. This may also be an incentive and example for other members to step up their efforts for the good of your council. A few of the awards are:

Ish Sodi:

Which may be defined as "man of my choice" or "select man".

10% Council Membership Gain Certificate.

First Responders Award:

Firefighters, Police etc. This can be for members or non-members. The non-members receive a pin and certificate.

Veterans Service Award:

This award can be for a member or non-member to recognize military service to our country.

Lady of the Council:

If your lady or any lady has given a great deal of support to Cryptic Masonry, then consider giving her this award. It is a nice jewel, and the cost is \$125.

Adult Youth Leadership Award:

The youth are a big part of our Masonic future. Youth leaders are critical in helping our youth organizations be successful.

Cryptic Mason of the Year Award:

This is a special award for exemplary service to Cryptic Masonry.

There are some additional awards that I will not go into detail now but information on the additional and the above awards can be found in the Award Booklet that is available on the Utah York Rite website. The Award Booklet was prepared by Companion Danny Drew.

In conclusion, it has been my honor and pleasure to serve Utah Cryptic Masonry this past year as the Most Illustrious Grand Master. I hope I have done at least some good. I sincerely appreciate all of your confidence and support. Even though my term is ending I will continue to support York Rite Masonry in Utah to the best of my ability.

LEGISLATION

Proposed change to the "Constitution, Laws & Regulations of the Grand Council Cryptic Masons of the State of Utah"

Whereas Section 3-5 of the By-Laws for the Grand Council Cryptic Masons of Utah states that a Quorum shall consist of 5 members of a constituent body to conduct business

And whereas the ritual book from the General Grand Council of Cryptic Masons International that has been adopted as the official ritual for the Grand Council Cryptic Masons of Utah does not contain a short form opening

And whereas there exists no short form opening to allow for the opening of a Council with less than 9 members

And whereas there exists no provision to declare a body open in the By-Laws for the Grand Council Cryptic Masons of Utah

Be it therefore resolved to accept the following Ritual as the official Short Form Opening to be used when there are at least 5 regular members of the constituent council present for the purpose of conducting business.

Select Master Short Form Opening

REPORTS OF OFFICERS

REPORT OF THE GRAND COMMANDER

Right Eminent Past Grand Commanders, Grand Commandery Officers, Distinguished Guests and Sir Knights, Good Afternoon. This is my report of my actions and decisions for the last year.

My year started off really well. In June, I attended Grand Rally for Job's Daughters in Price and awarded the Grand Commander's Trophy as well as attended several Job's Daughter installations.

In October, I attended the combined Northwest/Southwest Department Conference held in Salt Lake City. The information received is always interesting and enlightening.

I visited all 6 commanderies throughout the state during the year. I always receive a very warm reception whether it is an official visit or just attending a meeting. Everybody always made me feel very welcome.. I am pleased to say I was able to attend 5 of the 6 Christmas Observances held throughout the state. I attended a combined Malta/El Monte's, Ivanhoe's, and Golgotha's observances in December and Utah 1's observance in January. The only one I didn't attend was Charles Fred Jennings'.

This year I challenged the 6 constituent commanderies in the state to raise at least \$400 each for the Holy Land Pilgrimage so we can try to send another ordained minister to the Holy Land in a couple of years. We ended up raising about \$570 which is a start towards sending another pastor to the holy land.

We had a net loss of 7 sir knights over the last year. We knighted 14, affiliated 1 and reinstated 1. There were 7 demits and 10 suspended along with 6 deceased. As has been observed before, knighting new members is great, but we need to focus on retention and reinstatement.

I feel getting sir knights to come to meetings and keeping them engaged can be tricky. I would like to point out El Monte Commandery #2 in Ogden. Before and after Covid, they were having trouble getting enough people to come to meetings to even open. They added new members and got them involved. They started a pot luck before each meeting and invited the families. Now, they are averaging about a dozen members for each meeting with some coming from as far away as Utah County. They try to keep the meetings to no more than about an hour including educational features. Sometimes the educational is as simple as going over signs and grips from degrees that we don't use except for when degrees and orders are conferred. Other times the educational features delve into more esoteric parts of Freemasonry. That is just one example of something we, as a group, can do.

I was hoping to travel to other jurisdictions and represent the Grand Commandery of Utah but with work changing my schedule then then out losing my job in September, my travel plans changed drastically. It turned out easier for me to make my visitations throughout Utah though. My very eminent deputy grand commander represented me at some jurisdictions and I am very grateful for him to do that. I was able to attend Idaho's grand sessions on 19 and 20 April.

I approved two dispensations this year. One dispensation for Malta Commandery to hold a special meeting to propose by-law changes. The other one was for Golgotha Commander to hold a special meeting in Cedar City.

I approved a by-law change for Malta Commandery to move their meetings to the Tooele Masonic Temple.

I approved Meritorious Service Medals for the following individuals: Monte Anderson of Utah 1; William McCraw of El Monte #2, Joseph Radloff of Malta #3, Jayson Carlson of Ivanhoe #5, Aaron Weyant of Charles Fred Jennings #6, and Paul Erickson of Golgotha #7.

Recommendations:

First, before issuing a demit, conduct an exit interview to find out why they want to demit. Chances are that if they have lost interest in the York Rite because all they do is come to a meeting and discuss business, there is nothing of value added to the meeting. Think about adding an educational to each meeting that goes more in-depth.

I wish to thank Sir Knight Brian Hastings and the Jurisprudence Committee for their hard work this year; your advice was always welcome and very much appreciated.

LEGISLATION

Legislation to approve additional jewels to be worn on The Commandery Uniform

Whereas: The Jewels which can be worn on The Commandery Uniform are set by The Grand Commandery of Utah, Uniform Regulations;

Whereas: The addition of meritorious jewels and other Templar Jewels should be considered in The Grand Commandery of Utah, Uniform Regulations in order to reflect service to The Grand Commandery, Constituent Commanderies as well as All Sir Knights of Utah;

Whereas: The Uniform Regulations of The Grand Commandery of Utah, Regulation Jewelry, Ornamentation and Adornment of Uniforms would need to reflect definition of Meritorious Jewels;

The current Grand Commandery of Utah, Uniform Regulations, Regulation Jewelry, Ornamentation or Adornment of Uniforms states the following:

REGULATION JEWELRY, ORNAMENTATION OR ADORNMENT OF UNIFORMS The ONLY authorized equipment other than previously described to be worn on any Knights Templar Uniform of the State of Utah consists of the following, worn with the top of the medal or jewel aligned with the top of the wearers left breast pocket. No Lapel Pins or jewels may be worn on the lapels of Templar Uniforms.

Jewels from the wearer's right to left are as follows. Jewel of Office, Meritorious Jewels, and Malta Jewel. A jewel of the Past Commanders Association or Past Prior of the Past Commanders Association is considered a meritorious jewel. A maximum of 4 jewels may be worn on the Templar Uniform and one of those jewels must be the Malta Jewel.

The jewels authorized for wear in the State of Utah are: 1. Order of Malta, 2. Past Commander Association or Past Prior of Past Commanders Association, 3. Past Eminent Commander, 4. Jewel of Office of Constituent Commandery, 5. Jewel of Office of Grand Commandery 6. Jewel of Past Grand Commander. Awards of the Knight Templar Cross of Honor can also be worn on the left breast or suspended from a red ribbon from the neck. Only one jewel of office shall be worn at one time.

The State name (UTAH), gold in color, one-half (½) inch in height shall be worn one (1) inch above the left pocket and centered above the jewels.

The following uniform bars are authorized, and wear is optional. If authorized to wear the Veteran Service bar by virtue of service in The Armed Forces, it may be worn one-half (½) inch above the left pocket and centered above the jewels. If authorized to

wear the Meritorious Service (KYCH) uniform bar by virtue of membership in the Knights of York Cross of Honor (KYCH), it may be worn one-half (½) inch above the left pocket and centered.

Therefore, let the following resolution be entered for consideration;

The section concerning Regulation Jewelry, Ornamentation or Adornment of Uniforms be changed to read: (The Additions are highlighted in **Bold** *italics* and *underlined*)

REGULATION JEWELRY, ORNAMENTATION OR ADORNMENT OF UNIFORMS The ONLY authorized equipment other than previously described to be worn on any Knights Templar Uniform of the State of Utah consists of the following, worn with the top of the medal or jewel aligned with the top of the wearers left breast pocket. No Lapel Pins or jewels may be worn on the lapels of Templar Uniforms.

Jewels from the wearer's right to left are as follows. Jewel of Office, Meritorious Jewels, and Malta Jewel. A jewel of the Past Commanders Association or Past Prior of the Past Commanders Association is considered a meritorious jewel. A maximum of 4 jewels may be worn on the Templar Uniform and one of those jewels must be the Malta Jewel.

The jewels authorized for wear in the State of Utah are: 1. Order of Malta, 2. Past Commander Association or Past Prior of Past Commanders Association, 3. Past Eminent Commander, 4. Jewel of Office of Constituent Commandery, 5. Jewel of Office of Grand Commandery 6. Jewel of Past Grand Commander, 7. Any Meritorious Jewel presented By The Grand Commandery of Utah, 8. The Holy Land Pilgrimage Endowment Fund Jewel, 9. The Grand Encampment of Knights Templar, Commissioned Templar Chaplain Jewel.

Awards of the Knight Templar Cross of Honor can also be worn on the left breast or suspended from a red ribbon from the neck. Only one jewel of office shall be worn at one time.

The Meritorious Jewels presented by The Grand Commandery of Utah consist of the following: The Grand Commandery of Utah Meritorious Service Jewel, The Grand Encampment Meritorious Service Jewel, and any Meritorious Jewels developed at a later date by The Grand Commandery of Utah or The Grand Encampment of Knights Templar of The U.S.A.

The State name (UTAH), gold in color, one-half (½) inch in height shall be worn one (1) inch above the left pocket and centered above the jewels.

The following uniform bars are authorized, and wear is optional. If authorized to wear the Veteran Service bar by virtue of service in The Armed Forces, it may be worn

one-half ($\frac{1}{2}$) inch above the left pocket and centered above the jewels. If authorized to wear the Meritorious Service (KYCH) uniform bar by virtue of membership in the Knights of York Cross of Honor

(KYCH), it may be worn one-half (½) inch above the left pocket and centered.

Grand Commandery of Utah – Uniform Regulations (Aprons) Proposal

Whereas, the Grand Encampment of the United States of America adopted a resolution at the Grand Encampment triennial in 2021 to permit the use of Aprons of traditional and contemporary appearance.

Let it now be proposed that the Grand Commandery of Utah, adopt a uniform regulation similar to the Grand Encampment, regarding the use of Aprons.

Excerpt from the Grand Encampment Constitution and Statutes;

CHAPTER XXII APRONS Section 261.

It is permissible for Grand Encampment officers and members of Grand, Constituent and Subordinate Commanderies to wear an apron with Templar Uniforms as described in Sections 247, 248, 250, 250a, 251, and 259 as follows:

- A. Traditional Apron. A Traditional Templar Apron shall conform substantially in design to the images below. It shall be trimmed in gold for Sir Knights of the rank of Commander or Past Commander and above, and in silver for Sir Knights below the rank of Commander. A Traditional Templar Apron may only be worn in an asylum or other private setting where only Knights Templar are present.
- B. Contemporary Apron. A Contemporary Templar Apron shall conform substantially in design to the image below. It shall be trimmed in gold for Sir Knights of the rank of Commander or Past Commander and above, and in silver for Sir Knights below the rank of Commander. A Contemporary Templar Apron may be worn in both private and public settings. It is permissible to manufacturer an apron so that it is reversible

with the Traditional Apron on one side and the Contemporary Apron on the other.

- C. Grand Encampment Officers may wear such aprons and others, as deemed appropriate, from time to time, by the Grand Master and in accordance with his directions.
- D. If a Sir Knight appears in uniform in a Tyled, Masonic Lodge, he shall wear such apron as in accord with local Masonic custom or approved by the presiding officer. (2021, p unspecified) Section 262. A Grand Commandery may provide for the wearing of a Templar Apron in its uniform regulations similar to those in Sections 261 A, B and C.

A Grand Commandery may specify with which of its authorized uniforms a Templar Apron may be worn. (2021, p unspecified)

Upon approval by the Grand Commandery of Utah, the regulation shall appear as follows in the Grand Commandery of Utah Uniform Regulations:

CHAPTER XXII APRONS

It is permissible for Grand Commandery officers and members of Constituent Commanderies to wear an apron with Templar Uniforms as described below:

- A) Traditional Apron. A Traditional Templar Apron shall conform substantially in design to the images below. It shall be trimmed in gold for Sir Knights of the rank of Commander or Past Commander and above, and in silver for Sir Knights below the rank of Commander. A Traditional Templar Apron may only be worn in an asylum or other private setting where only Knights Templar are present.
- B) Contemporary Apron. A Contemporary Templar Apron shall conform substantially in design to the image below. It shall be trimmed in gold for Sir Knights of the rank of Commander or Past Commander and above, and in silver for Sir Knights below the rank of Commander. A Contemporary Templar Apron may be worn in both private and public settings. It is permissible to manufacturer an apron so that it is reversible

with the Traditional Apron on one side and the Contemporary Apron on the other.

- C) Grand Commandery Officers may wear such aprons and others, as deemed appropriate, from time to time, by the Grand Commander and in accordance with his directions.
- D) If a Sir Knight appears in uniform in a Tyled, Masonic Lodge, he shall wear such apron as in accord with local Masonic custom or approved by the presiding officer. A Commandery may provide for the wearing of a Templar Apron in its uniform regulations similar to the approved regulations of the Grand Commandery of Utah.
- E) The Aprons may be worn with approved uniforms as outlined in the Grand Commandery of Utah Uniform Regulations. As is typical, with other articles of the uniform, all Sir Knights should be matching. When Sir Knights are assembled in uniform, all must wear the same uniform.

Adoption of this addition to the Uniform Regulations of the Grand Commandery of Utah, shall take effect upon approval of the Grand Commandery of Utah during its annual Conclave in May of 2024.
